

## OPPOSE HOUSE BILL 5724

This Bill is not just about the Judge's addresses, their assets they have acquired and their social security numbers. This Bill is a stepping-stone to allow the Judges, the State Court Administrative Office and the Michigan State Bar Members to take over our Courts for their own financial benefit and self-interest.

Please STOP House Bill 5724 from moving forward and reread Section Six, Article 25 of the 1963 State Constitution of Michigan. We have reasonable cause that the Legislators are failing to hear the voices of Michigan Litigants.

The Legislators who drafted this Bill - on behalf of the Judges - must remember they are elected to protect the well being of The People in Michigan. During Probate Hearings, our whole family histories are put out into the Court Record while many attorneys are able to place false narratives on the court record without any consequences.

This Legislative Body is to protect the People from bully tactics of the Judiciary Branch and it is shameful that the creators of this Bill have ignored our pleas and are - instead - protecting the Judges.

My name is Jody White and I am a familiar face at the Judiciary Committee Meetings. I was a 2018 House Representative Candidate for District 16 and a Senate Candidate in 2022 for District 5 regarding the topic of **how Probate Judges are harming our Michigan Families**.

It is of public knowledge that I was assaulted by an Oakland County Deputy Sheriff, Paul Thieme, after I went to the Probate Annex to file a complaint on Probate Judge Daniel A. O'Brien for his failure to mandate his own court appointed attorney to file the annual accounting for our family's estate back in September of 2018. Where is the Bill to protect me?

The day of the physical assault, our family received the Court of Appeals Opinion that reprimanded Judge O'Brien that stated he did err by not providing our family with a Trial by Jury.

Where is the Bill to protect families that follow the Court's Protocols and pay thousands of dollars to the Judiciary Economy to protect our right to Justice?

Where is the Bill to mandate Judge O'Brien to follow through with the Trial by Jury that our family paid for but never received?

Where is the Bill to protect families that are threatened, harmed and even assaulted by the Judiciary?

I, and many other family members, have gone to the Attorney General, the Supreme Court Justices and to multiple Legislators, Commissioners and Agencies **requesting oversight and review** of these Probate Judges in Michigan.

We the Victims of Probate are **requesting civil actions** to commence with our Legislators **to compel compliance** with these Probate Judges.

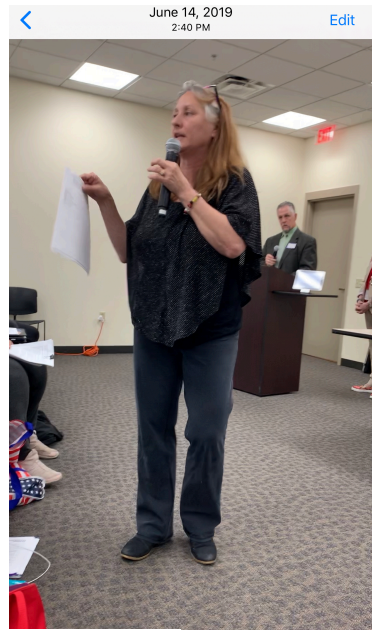
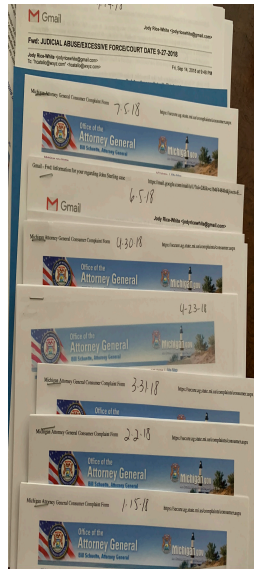
We the Victims of Probate want **actions for injunctive relief** for the harms done to Michigan Families since 2017.

I am not the only person who has been threatened or harmed by the Judiciary. Multiple family members have joined me here in Lansing to expose the malfeasance and misfeasance of Probate Court Judges who are failing the Public when it comes to our elders, our assets and our legacies.

Last Fall, Dana Nessel and Scott Teter from the Office of the Attorney General have pleaded with the Legislators to create LAWS to protect the General Public and now in 2024 – we are notified that the Judges and the State Court Administrative Office are being granted more legislative and administrative powers to bully the General Public when we use our freedom of speech to post the TRUTH about their actions. This is egregious.
