## **COMMITTEE MEETING MINUTES**

The House Appropriations Subcommittee on Military and Veterans Affairs and State Police was called to order by Chair Morgan.

The Chair requested attendance be called:

Representative Brabec moved to adopt the meeting minutes from March 19, 2024. There being no objection, the motion prevailed by unanimous consent.

Rep. Morse moved to place the House Substitute for HB 5509 (H-1) before the House Subcommittee for discussion.

The motion prevailed 7-0-0:

Rep. Morgan called on Michael Cnossen, Fiscal Analyst from the House Fiscal Agency, to provide highlights of House Bill 5509 (H-1), the House Subcommittee Chair recommended FY 2024-25 Department of Military and Veterans Affairs budget and to answer members' questions.

Rep. Cavitt moved to amend the bill to revise Sec. 306. regarding expenditures from the Billeting Fund.

The motion did not prevail 3-1-3:

Rep. Green moved to amend the bill by inserting Sec. 416 to permit contracting to accelerate research for treatments for suicide prevention.

Rep. Slagh moved to amend the bill to revise Sec. 410 to restore the requirement regarding maintenance of staffing and resources.

The motion did not prevail 3-4-0:

Rep. Wilson moved to refer House Bill No. 5509 (H-1) to the House Standing Committee on Appropriations with recommendation that it pass.

The motion prevailed 4-2-1:

Rep. Brabec moved to place the House Substitute for HB 5510 (H-1) before the House Subcommittee for discussion.

Rep. Morgan called on Michael Cnossen, Fiscal Analyst from the House Fiscal Agency, to provide highlights of House Bill 5510 (H-1), the House Subcommittee Chair recommended FY 2024-25 Department of State Police budget and to answer members' questions.

Rep. Cavitt moves to amend the bill to revise Sec. 407 to restore inclusion of reporting based on an analysis of school safety grants.

The motion did not prevail 3-4-0:

Rep. Slagh moved to increase funding for the Public Safety Officers Benefit program from \$303,000 to \$600,000.

Rep. Morse moved to refer House Bill No. 5510 (H-1) to the House Standing Committee on Appropriations with recommendation that it pass.
