

### MCEDSV URGES SUBCOMMITTEE TO RESTORE \$2 MILLION FOR SEXUAL ASSAULT COMPREHENSIVE SERVICES

**Comments before House Appropriations Subcommittee on the** Department of Health & Human Services (DHHS)

### March 9, 2020

The Executive Budget Proposal for FY 20-21 eliminates \$2 million GF/GP for Sexual Assault Comprehensive Services ("SA COMP"). It is absolutely critical that this funding be restored.

Restoring this funding in the DHHS Budget would:

- Allow the almost 100% increase in Comprehensive Sexual Assault Services to continue in the next fiscal year, sustaining the dramatic increase in the number of survivors and communities receiving these essential services; and
- Allow local programs to continue to access additional Victims of Crime Act ("VOCA") grant funding, through a separate competitive grant process, by increasing the resources they would have available to demonstrate match when required.

It is important to note that SA COMP and VOCA funding does not cross-over and cannot be comingled at the state level. SA COMP dollars awarded do not result in an automatic VOCA match. However, SA Comp dollars awarded to a local program can be used by that program to apply for and be granted additional VOCA funds that otherwise would not be accessible.

Sexual assault comprehensive services grant...... \$ 2,000,000


### Requested Boilerplate language:

"From the funds appropriated for sexual assault comprehensive services grant, \$2,000,000.00 shall be allocated to the Michigan Domestic and Sexual Violence Prevention and Treatment Board (MDSVPTB) for sexual assault comprehensive victim services funding, as defined by MDSVPTB, to be distributed through a competitive grant process to entities determined by MDSVPTB to have demonstrated capacity to provide such services."

## VOCA Appropriation / grants Process (50350)



Funds designated for sexual assault services


### Issue: Need to expand Comprehensive Sexual Assault Services in MI

- Current funding is insufficient.
- Federal VOCA funds have limited uses / other restrictions.
- Local sexual assault programs cannot currently bid for all available SA VOCA funding because they do not have sufficient non-federal grants contributing to the project.

Solution: State Funding (supported by GF-GP) to allow local sexual assault programs to apply for separate non-federal grant dollars, that can be used to:

- Support expenses for critical survivor services that are not allowable in VOCA grants; and ...
- Leverage additional VOCA funds for local programs.

MDSVPTB Appropriation / grant Process (64060)



New Comprehensive Sexual Assault Funding (GF)



The two appropriations do not crossover or comingle. <u>NEW</u> GF-GP sexual assault funding would allow <u>local programs</u> to document that other funding is available to help support services. This would provide increased resources for comprehensive services, support costs unallowable under the VOCA regulations, AND enable programs to bid for additional VOCA funding.
