We optimize and diligently manage the resources entrusted to us. With responsible, sustainable, and ethical practices we create lasting value for our clients and the broader community.

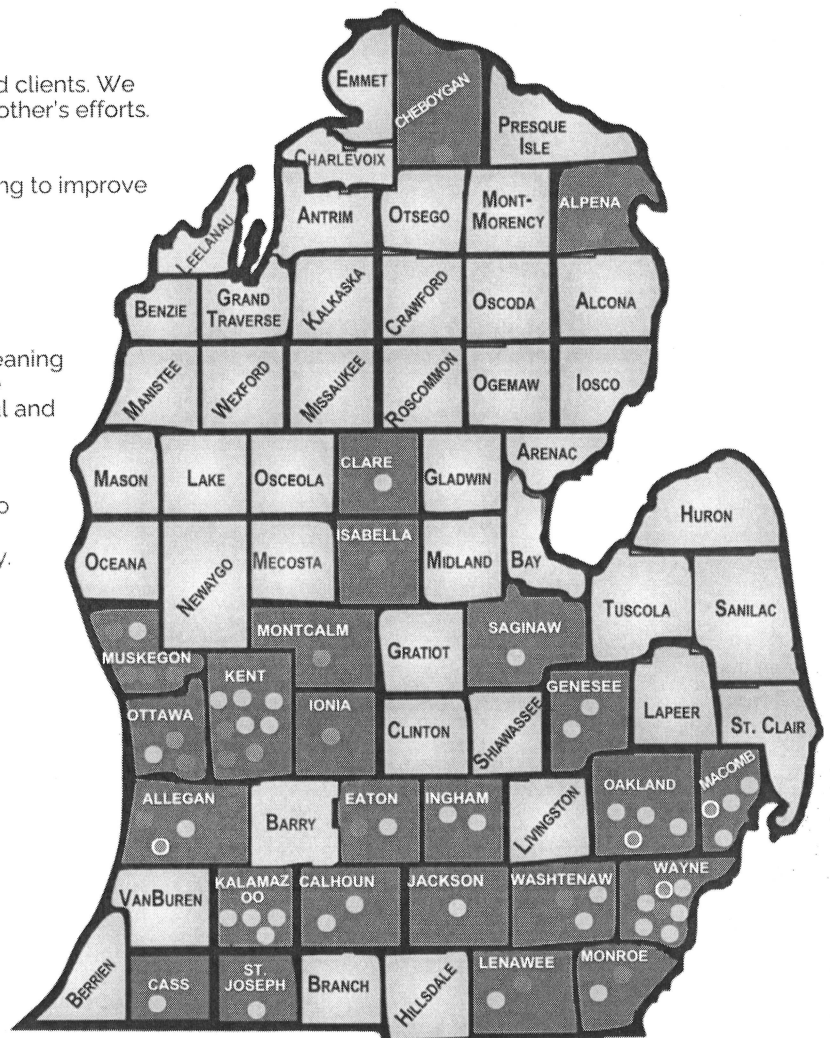

### Medication Assisted Treatment (MAT)

### Group Therapy

### Intensive Outpatient Program (IOP)

A higher level of care that allows clients to receive structured support while living at home.



### Recovery Coaching

Peer-led support to navigate triggers, manage stress, and foster a sober, fulfilling life.



### Case Management

Guidance and practical support to help clients rebuild essential life skills and routines.



### Psychiatric Services

Compassionate behavioral health care for those facing depression, anxiety, or other mental health challenges.
