2024 Accomplishments



Bureau of Construction Codes (BCC)

BCC increased the number of annual elevator inspections by 22% in 2024. Since 2021, elevator inspections have gone up by 57%.



Bureau of Community and Health Systems (BCHS)

BCHS implemented the new Michigan Nurse Aid, Training, and Enforcement System (MI-NATES). This registry is a management information system for certification of nurse and medication aides, as well as permitting for nurse and medication aide trainers and training programs.



Michigan Public Service Commission (MPSC)

MPSC worked to implement the new clean energy laws. These laws include a new clean energy standard, increased renewable energy goals, a new energy storage target, and changes to public participation, rate case processes, and siting for large energy projects.



Bureau of Fire Services (BFS)

MI Prevention, a statewide community risk reduction program, reached a milestone of installing over 100,000 smoke alarms in Michigan homes since the start of the program in 2019.



Michigan Indigent Defense Commission

MIDC implemented Standard 8, Attorney Compensation. This standard ensures all attorneys providing indigent defense services are adequately compensated for their time and incentivized to provide quality work.

2024 Accomplishments



Bureau of Professional Licensing (BPL)

BPL issued over 63,000 new licenses and processed over 249,000 license renewals for Public Health Code and Occupational Code professions.



Bureau of Survey and Certification (BSC)

BSC improved the process of filing complaints by revamping its webpage and online complaint forms.



Corporations, Securities, and Commercial Licensing (CSCL)

CSCL launched the Michigan Business Roadmap website which represents a collaboration between LARA and the Department of Labor and Economic Opportunity (LEO).



Cannabis Regulatory Agency (CRA)

CRA transitioned to unannounced semi-annual inspections at all licensed marijuana businesses to better identify bad actors that negatively impact the industry.

Implementing enacted legislation for clean energy and a medication aide training and registration program

Expanding access to qualified interpreters for Deaf, Deafblind, and Hard of Hearing individuals

Enhancing educational outreach and consultive services throughout LARA

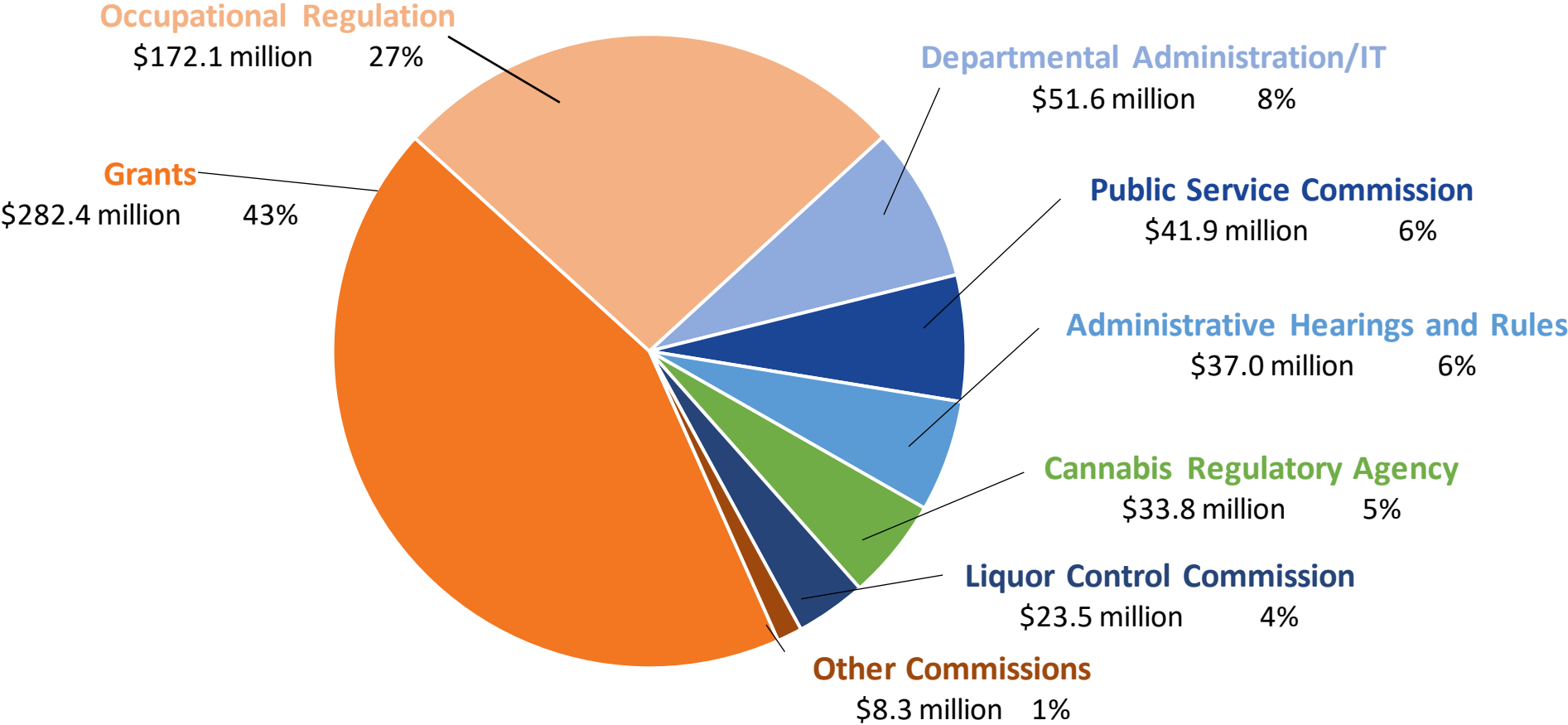

The FY 2026 Budget

- Since taking office, Governor Whitmer has worked to lower costs for Michiganders on higher education, skills training, home repairs, childcare, housing, health care, and more, while remaining fiscally responsible resulting in a budget surplus.
- The Governor's FY 2026 budget continues to deliver on lowering costs and growing Michigan's economy.
- The FY 2026 budget cuts red tape, supports public safety, improves and powers economic development across Michigan, helping make state and local governments work more effectively so they can better serve Michiganders.
- LARA's FY 2026 budget request enhances quality health care by strengthening oversight of long-term care facilities and acute and continuing care provider types.

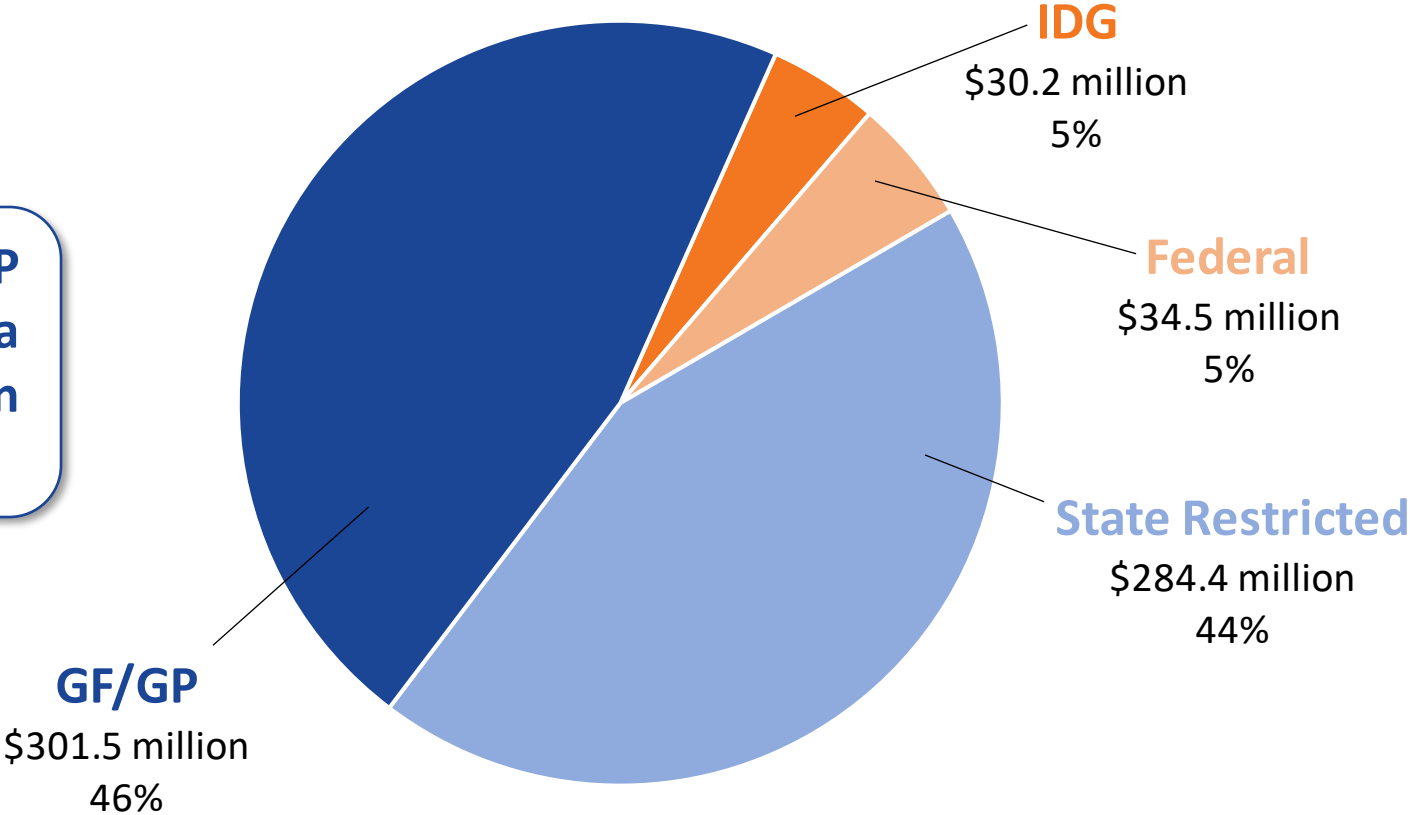


LARA FY 2026 Recommended Budget

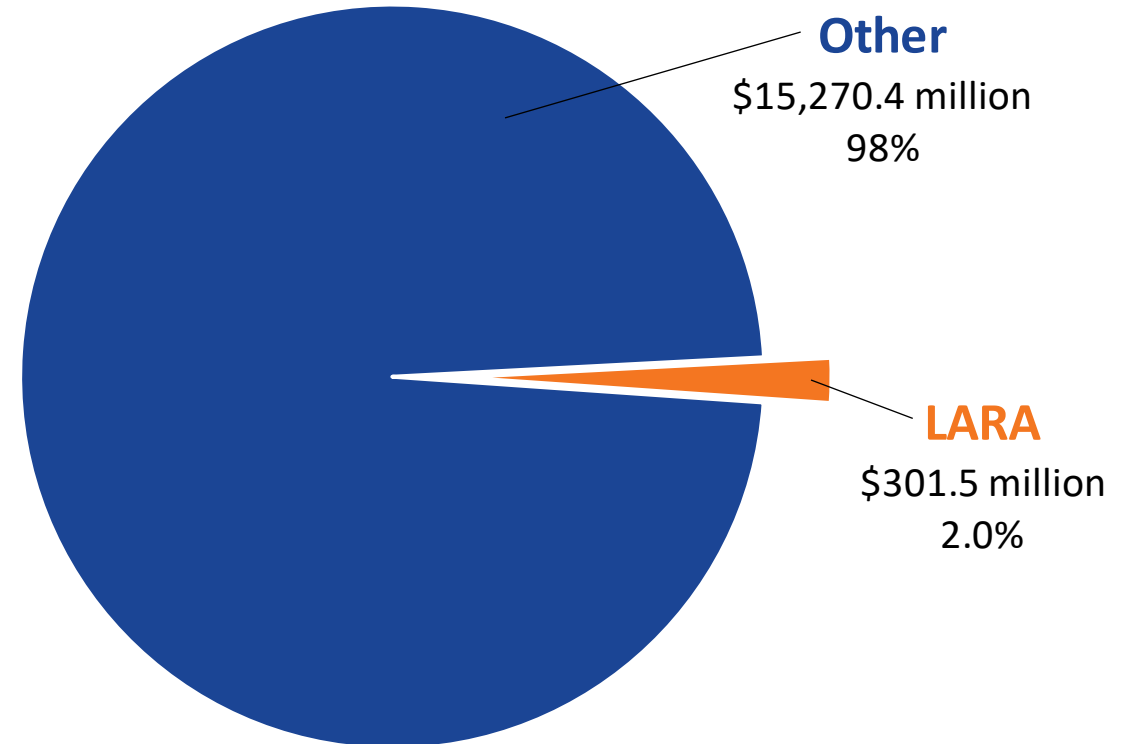
\$301.5 million GF/GP

Improve Oversight of LTC Facilities and ACC Provider Types

\$2.7 million GF/GP to hire 18 new health care surveyors and two complaint intake unit staff, supporting:

- Inspection of 424 Long-Term Care Facilities and over 20 Acute and Continuing Care provider types
- Investigation of roughly 7,000 complaints annually

Investigations started within the CMS-required timeframe (FY 2024)*	
Long Term Care Immediate Jeopardy	71%
Emergency Medical Treatment and Active Labor Act Non-Immediate Jeopardy High Priority	49%

Strengthen Regulation of Homes for the Aged

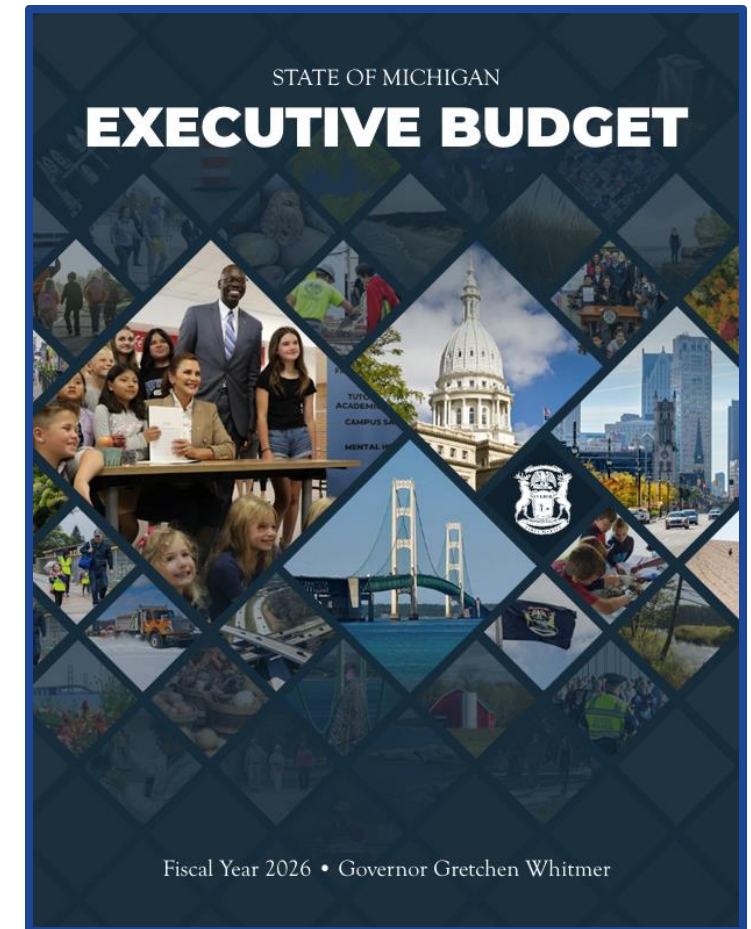
\$700,000 GF/GP and 3.0 FTEs to support:

- Timely issuances of new licenses and renewals
- Accurate Routine inspections of 348 Homes for the Aged
- Investigation of 748 complaints in FY 2024

- Implementing new federal grant awards for updating the statewide energy code and energy benchmarking
- Improving oversight of long-term care facilities and Homes for the Aged to strengthen protections for vulnerable residents
- Upholding public health and safety in death care services
