8. Purpose of the legislatively directed spending item. Please include how it provides a public benefit and why it is an appropriate use of taxpayer funding. Rx Kids is a legislatively directed initiative designed to address one of Michigan's most pressing public health and economic challenges: the high cost of raising a child and the associated disparities in maternal and infant outcomes. The program provides unconditional cash transfers to all pregnant women and infants in participating communities, offering \$1,500 during mid-pregnancy and \$500 per month during the child's first year of life. Grounded in global evidence and modeled after successful programs like the expanded federal Child Tax Credit, Rx Kids has already demonstrated

strong public benefit outcomes, including improved maternal mental health, higher birth weights, reduced infant prematurity, and enhanced financial stability among families. The universal, time-limited, and efficient design of Rx Kids maximizes take-up and minimizes administrative burden, ensuring that public funds are used effectively to reach the most critical developmental stage of life.

Funding Rx Kids is an appropriate and justified use of taxpayer dollars. The program not only promotes health and well-being but also strengthens Michigan's workforce and economic outlook by reducing long-term costs associated with poor maternal and infant health outcomes, such as NICU stays, child welfare interventions, and economic instability. In leveraging federal Temporary Assistance for Needy Families (TANF) funds through the "non-recurring short term benefits" provision, combined with state general funds and philanthropic support, Rx Kids creates a sustainable and scalable model for statewide impact. Importantly, the funding structure includes safeguards to protect public benefits eligibility, avoids the "benefits cliff," and supports immigrant and underserved populations where state funds cannot be used directly.

Rx Kids: Prenatal and Infant Support Program



In January 2024, Michigan boldly re-imagined how we invest in families with the historic launch of Rx Kids in Flint. As the nation's first-ever citywide prenatal and infant cash prescription program, Rx Kids is already providing lifechanging financial security to an entire generation of children.

With almost 100% uptake in Flint, Rx Kids has prescribed over \$6 million to over 1,400 families. Rx Kids is eliminating infant poverty and reimagining the social contract while joyfully changing the lives and trajectories of countless families.

Eliminating Infant Poverty: Michigan as a Model

Built on the tremendous success of Rx Kids in Flint, along with global and national evidence, **the expansion of the universal and no-strings-attached Rx Kids program** will improve health, revitalize local economies, and help families get the support they need to thrive.


With leadership from the Pediatric Public Health Initiative at Michigan State University and Poverty Solutions at University of Michigan, and with expert administration by GiveDirectly, the Rx Kids program and evaluation infrastructure is **already built and ready for implementation** in other enthusiastic communities.

Utilizing the TANF non-recurrent short-term (NRST) benefits provision designed to support lower income families during an acute episode of need, TANF funds are blended with other public and/or philanthropic support to create a targeted universal program that is efficient to administer and reaches all pregnant individuals and babies in low-income communities.



Research and Impact

MULTI-GENERATIONAL AND COMMUNITY IMPACTS

Cash prescriptions during pregnancy and early childhood are powerful tools proven to positively impact health, hope, and opportunity.

Key Participant Survey Findings

The program is showing incredible impacts on the financial stability and health outcomes of its participants:



- ♥ 70% of respondents make less than \$10k annually
- 88% of participants say that Rx Kids has helped them make ends meet and feel more secure in their finances.
- 86% of participants who are currently pregnant went to at least one prenatal care
 appointment in the past three months and 96% of participants with infants going to at
 least one pediatric visit in the past three months
- 84% say that the money from Rx Kids has helped them become more confident as parents
- ♥ 67% feel that Rx Kids has helped to improve their health and that of their infants

Many moms report that they felt the money from Rx Kids has helped them become more confident in themselves as parents. **The top five items cash is spent on include baby supplies, food, rent, utility bills, and transportation.**

IMPROVING MATERNAL-INFANT HEALTH AND ADVANCING HEALTH EQUITY

Maternal Research Study

Maternal research findings indicate that Rx Kids has been successful in strengthening family financial security and improving maternal mental health and wellbeing. Key findings include:

- Rx Kids families were more likely to have "enough of the kinds of foods we want"
- Rx Kids families were much more likely to be paid in full on their rent or mortgage
- No low-income Rx Kids moms were evicted
- Rx Kids were less likely to exhibit symptoms of post-partum depression
- Rx Kids moms are more likely to report they feel loved, hopeful, valued, and respected
- Rx Kids moms were more likely to report having a high trust in health care and govenment

Additionally, preliminary findings from birth certificate data reveal improved maternal and infant health outcomes including more prenatal care, earlier prenatal care, less smoking, and impacts on birth weight and prematurity. Overall, Flint moms and babies are faring better in 2024 than in previous years or in nearby geographies.


