New Lothrop Road Bridge over the Shiawassee River

The Shiawassee County Road Commission is requesting local bridge funds for the **replacement** of the New Lothrop Road Bridge over the Shiawassee River. The Shiawassee County Road Commission is committed to having this structure funded for the 2027 fiscal year. This bridge is the Road Commission's #1 priority for funding.

BACKGROUND

The New Lothrop Road Bridge over the Shiawassee River is a three span steel beam structure totaling 139 feet in length. The structure was originally constructed in 1955. This structure carried 2 lanes of traffic with a clear width of 24 feet. The bridge is in **critical** condition and has been closed. The HMA surface with chip seal has light reflective cracks above the piers and short transverse cracks have been sealed. The bridge railing consists of R5 railing and concrete brush block with a thrie beam retrofit. The concrete deck bottom has cracking with efflorescence at the abutments, and moisture and spalls to steel at the deck drains. Abutments are concrete curtainwalls. The south abutment has three vertical cracks and the north abutment has two vertical cracks. The piers consist of concrete wall footings, eight H-piles and a concrete cap. There is light surface rust on all pier columns with moderate pack rust and section loss under pier caps. Pier caps have vertical hairline cracking, spalls to steel, and rust staining. Abutments are well above the water, water flows along the inside face of the pier footings.

A detailed inspection was completed on July 31, 2023 and the following extensive deterioration was found. The beams consist of six WF steel stringers in critical condition with heavy pack rust and holes throughout. The end diaphragms have heavy section loss due to the leaking expansion joint above, and all beams in span 2S are sagging 1/2" to 1". Span 1S, beam 2W at pier 1S has a hole in the H-bearing below the web and is buckled above the bearing. Span 1S, beam 5W at pier 1S has a hole in the H-bearing. WEIGHT LIMIT

The structure is currently closed. The structure was closed after a detailed inspection was completed on July 31, 2023.

FUNCTIONAL CLASSIFICATION AND ECONOMIC IMPORTANCE

New Lothrop Road is classified as a "major collector" and is a county primary road. It is a 2-lane HMA road which carries local, commercial, and agricultural traffic. Replacement of this bridge is critical to maintain an unrestricted roadway to help feed residential growth and retain the agricultural sector.

9817 – New Lothrop Road over the Shiawassee River The 2011 average daily traffic volume was 2,055 vehicles per day (vpd). The future traffic volumes (2044) are estimated to be 2,853 vpd. The economic importance of this structure is based on the increase in travel time due to the length of the detour route.

LOCAL IMPACTS AND DETOUR ROUTE

As this structure has been closed to traffic since July 2023, the posted detour route for traffic is as follows: New Lothrop Road to Bath Road, to Byron Road, to Miller Road, and back to New Lothrop Road. The approximate length of this detour is 8.1 miles utilizing paved primary roads.

The closure of the New Lothrop Road bridge has severely impacted travel for emergency vehicles, residential traffic, and school traffic including school buses. Because of the location of the closed bridge, and the railroad track east of New Lothrop Road, when a train is running, there is up to a 6-minute additional delay to emergency vehicle response. Police response is also delayed to the local High School and Elementary School, which are located on Bath Road approximately 1.0 mile from the New Lothrop Road bridge. Two school bus routes have been rerouted due to the closure causing increased traffic through residential areas, increased drive time on local un-paved roads, and increases to fuel consumption and bus repairs. Closure of the bridge has also increased traffic in the area causing delays which has led to increased driver speeds. This causes a safety hazard to both drivers and pedestrian cross traffic.

Dear Mr. Cannon,

I am writing this letter regarding the October 2023 closure of the New Lothrup Road bridge which is located in the Byron Area. This bridge closure is negatively impacting our school district, including students, staff, and community members.

A big impact for us is the fact that we have had to reroute two bus runs which has caused an increase in the time that our students are on the bus. This rerouting has also caused an increase in the fuel consumption for our district. Our buses now must spend additional time traveling through more residential areas since they can no longer take the direct New Lothrup Road to Bath Road route. This route used to go directly into Byron and the High School and Elementary Schools. Our busses also must spend more time now on the non-paved roads, which further strains our budget because of having to make more repairs as the spring thaws are always hard on our busses.

Also of concern to us is a safety issue regarding law enforcement response time. Byron has a cooperative agreement with the Durand Police Department and this bridge closure has increased the police response time, since they can no longer come directly south from Durand and turn left on Bath Road. They must now turn left on Lehring Road and drive through a residential area, then turn right on Byron Road, traveling through town.

In conclusion, this bridge closure is definitely having a negative impact on our school district and community. We greatly appreciate the Shiawassee County Road Commission's efforts to get a new structure in place as quickly as possible!
