Phase 1 of the project is a full facility renovation. Originally built in 1955 and expanded in the mid-1970s to meet the growing need for community fitness space (including racquet ball courts), our nearly 27,000 square foot facility is vintage, and, in all practical ways, outdated. This renovation will replace all the original 1955 infrastructure which is at the "end of life" phase of functioning. The 18,000 square foot main level will be reconfigured to include not only our fitness center, martial arts Dojo, lobby/reception area, offices and

gymnasium but also four licensed childcare rooms for infants through preschoolers. This phase has a budget of \$2.5 million of which we have \$1.95 million secured, leaving a deficit of \$550,000 for which we intend to launch a public campaign and secure final advance gift donors. Equipment is not included in this figure; with new fitness equipment (\$350K) and additional site preparation, the total for Phase 1 is \$3,789,800. See attached budget. We have secured a bridge/construction loan and will begin this phase in Q3 of 2025.

Phase 2 of the capital project will add square footage to our current footprint. This expansion will double our gym space and add 4000 square feet of community space which can be utilized by groups, families, teams or organizations as casual event space, meeting space, or, as is desperately needed with our teenage members of the community, as a "hang out" space. Similarly, this expanded space will provide a location for active older adults/seniors to come together and be part of a community within the community, alleviating social isolation and loneliness. Finally, this additional space will allow the SFYMCA to provide a heating/cooling center (none exists in the county currently) as well as serve as a site for disaster preparedness training as well as shelter in the case of a county-wide or city-wide emergency. This phase of the project's budget is just under \$6 million. See attached budget. We will be site/construction ready for this phase by the end of Q3 2025 and hope to begin this expansion phase in 2026 pending funding.

#### **ENTITY DESCRIPTION**

The Shiawassee Family YMCA was incorporated as a 501c3 in 1947. We have served our community from our current facility since 1955. Founded on the mission of putting Christian principles into practice through programs that build healthy spirit, mind and body for all, the Shiawassee Family YMCA (SFYMCA) serves all within the greater Shiawassee County community. Our vision continues to evolve as we strive to increase our impact in youth development, healthy living and social responsibility. As part of the YMCA of the USA, we are a standalone nonprofit and part of a nationwide movement. A cornerstone in the community, we are collaborators, conveners, and supporters of all. Located at the intersection of M-21 and M-52, two main trunks in the county, the Y is situated in the quadrant of Owosso that has the highest level of rentals, lowest level of income, and few organizations that support those most in need in the community.

Today we serve over 4000 individuals within our facility yearly and thousands more through our feeding efforts out in the community. As the largest youth serving nonprofit in the county, nurturing the potential of every child and teen, we believe values and skills learned early on are vital building blocks for life. The SFYMCA is an equalizing organization where ALL youth can learn how to be on a team, learn to advocate for themselves, learn to develop positive relationships and so much more. Grant funds and sponsorships allow us to offer free programming to many youths, most of whom would not be able to participate otherwise.

As the level of poverty and ALICE numbers increase, we have watched our financial assistance grow from serving 23% of our members/participants in 2017 to serving over 75% of our members/participants in 2023. In 2024, 83% of our program participants (soccer players, youth in OST programs, campers, etc.) and 76% of members received some level of financial assistance. We have always focused on improving community health and well-being. Being healthy means more than simply being physically active; it's about maintaining a balanced body, mind and spirit. The Y is a place where anybody can work toward that balance by challenging themselves while fostering connections with family and friends. We provide a complete health and fitness center including cardio equipment, free weights, a Cybex circuit, a racquetball court, fitness and aerobic studios, and access to a full gymnasium. We offer a variety of evidence-based health initiatives for adults with chronic health needs including LiveStrong at the YMCA, Moving for Better Balance, Enhance Fitness, in addition to a diverse offering of group exercise classes. As the largest Silver Sneakers facility in the county, we provide free memberships for seniors helping them maintain and improve their health as well as the opportunity to build community within the YMCA walls. Much of the programming we provide in 2023 and 2024 was tweaked or new in response to needs that emerged from the pandemic. Finally, we feed our community regularly through mobile food pantries and providing weekend food bags to youth. We have distributed over 720,000 meals and 700,000 pounds of food to our community since summer 2020.

#### PURPOSE/GOAL OF PROJECT

The Shiawassee Family YMCA capital project is a multiphase project. Phase 1 of the project is a full facility renovation. Originally built in 1955 and expanded in the mid-1970s to meet the growing need for community fitness space (including racquet ball courts), our nearly 27,000 square foot facility is vintage, and, in all practical ways, outdated. ### Goals of this project:

- 1. To provide quality, affordable licensed childcare for families in the surrounding community at our current facility. (Phase 1)
- 2. To create welcoming, no cost community spaces for all, including teens, seniors and underserved groups from the community. (Phase 2)
- 3. To create no cost gathering spaces for community-based organizations and groups to utilize for training, meeting and celebrating. (Phase 2)
- 4. To provide a safe, welcoming space for youth in the community where they will participate in a variety of activities all under the direct and indirect supervision of YMCA youth staff and volunteers. (Phase 2)
- 5. To update our facility to be ADA compliant as well as inclusive space following universal access design principles. (Phase 1)
- 6. To create a Resiliency Center to be utilized by the community in severe weather and any other emergencies. (Phase 2)

This project will help the YMCA continue to be the equalizing organization for those individuals and families under the ALICE threshold (49% of households in the City of Owosso). Lack of accessible, affordable licensed childcare impacts parents' and caregivers' ability to maintain employment. Although our countywide unemployment numbers have improved since the

pandemic, according to the latest Census data, our county has seen a small decrease in employment rates from the previous year. The increase in the number of ALICE households indicates that families continue to struggle financially. Not being able to go to work due to lack of childcare is still impacting many of these families, especially single parent families according to county leaders.

This project will also double our gym space and create community space for youth, seniors, organizations and community groups to gather, to play, to train, to plan, and to get physically active together. In the last few years, the roller rink, bowling alley, arcade, and indoor sports arena in Owosso have all closed. Our teenagers no longer have a "hang out" beyond school. This project would not only provide an open gym during all hours of operation, but we would also have the community gathering space necessary to provide formal and informal programming for our young adults. As Surgeon General Dr. Vivek Murthy notes, communitybased organizations like the YMCA can play a pivotal role in helping communities address the youth mental health crisis (see attached article for reference). Our YMCA embraces this role, and once complete, this project will create space for all youth in our community to engage with nurturing adults (staff and volunteers) to help them learn positive relationship building, selfconfidence, leadership skills, communication skills, and how to give back to their communities. Dr. Murthy believes we can lead mental health crisis prevention efforts as well as destigmatizing asking for mental health support. We are up for that challenge, and the 10,400 school aged youth and teenagers that reside in this county who have no place to just be kids will benefit from our stepping into this role. Additionally, as the SFYMCA has transitioned into a community hub, we recognize the challenge our facility can be to seniors and those with disabilities since we are not ADA compliant. The project will remove this barrier. According to the latest Census data, having barrier free access to our facility could impact nearly 14,000 seniors in the county and over 8500 individuals with disabilities. Finally, the county is in dire need of a resiliency center where community space exists, and community members can gather in extreme weather situations or emergency situations. The added benefit of having a community space where disaster preparedness learning experiences can be facilitated for any community members is much needed.

#### JUSTIFY THIS PROJECT

### This project will:

- Create 12 additional jobs at a minimum.
- Provide licensed childcare for infants through preschool to help address the childcare shortage in our community, helping employers with employee recruitment and retention.
- Help our community focus on healthy living, especially those most vulnerable who may not regularly have access to health and wellness opportunities.
  - Increasing services for healthy living such as evidence based chronic disease management and prevention support and nutrition classes.
  - Provide spaces for family recreation and expand current family recreation offerings.

- Provide spaces for youth to gather and experience positive relationships and activities beyond their school days.
- Expand after school offerings to include civic health programming and other opportunities for youth to develop leadership skills, develop an understanding of the world around them and their place in it, and develop an understanding and appreciation for those around them.
- Create an ADA accessible, universally designed facility by creating spaces for all regardless of ability, lifestyle, or situation in life.
- Help our organization address the negative social determinants of health that became more obvious during the pandemic. Specifically, we will:
  - Provide expanded opportunities for youth, seniors, and the general population to be more physically active to help combat growing health concerns of obesity/being overweight, diabetes, and heart disease.
  - Provide expanded opportunities for youth to engage in positive, evidence-based learning experiences based on the YMCA's values of caring, honesty, respect and responsibility.
  - Create a welcoming space for seniors.
- Create opportunities for our three highest ALICE population households (single-female headed with children at 56%, single-male headed with children at 54%, and our seniors 65+ at 50%) to help alleviate stress and work toward a healthier lifestyle which diminished during Covid.
- Provide free, safe public recreation space. During and after Covid, our community saw all youth gathering businesses close (the roller rink, the bowling alley, an indoor sports arena, and an arcade). Those with resources can travel outside our community to have youth recreation experiences, but those families living in poverty (11%) or our ALICE families (29%) do not have these resources. Our YMCA is a community hub, but we will truly become that free community center after we renovate and expand our footprint.
- Create a health and wellness environment where all are welcomed regardless of age, race, income, ideology, identity, cultural background, faith, gender or sexual orientation. None currently exists in our rural community.
- Create a health and wellness environment where all are welcomed regardless of age, race, income, ideology, identity, cultural background, faith, gender or sexual orientation.
   None currently exists in our rural community.
- Create resiliency space heating/cooling space, space for gathering in community wide emergencies as well as classroom space for disaster preparedness learning and other community needs.

### **PROJECT SUMMARY**

Describe the project and how it builds readiness and resiliency in your community. What makes this project especially important and timely (please limit response to 300 words or less)?

The Shiawassee Family YMCA's two-phase renovation and expansion project in Owosso is a critical initiative addressing critical community needs, including childcare shortage in Shiawassee County. With only 1,891 licensed childcare spots available for over 2,400 children aged 0-12 in Owosso alone, this project aims to significantly increase the county's childcare capacity. Phase I childcare expansion (27,000 sq ft remodel) will serve 100 families, create at least 12 full-time staff positions, and offer extended care hours to accommodate diverse family schedules. Additional features in Phase II (15,000 sq ft addition) include a renovated workout facility, second gymnasium, commercial kitchen, and community spaces. This initiative builds community readiness and resiliency by creating a comprehensive center for child development and community engagement, offering unique programs in response to the needs of this rural community.

The project's importance lies in its comprehensive, community-focused approach and is responsive to community needs gathered from a variety of county residents and sources such as the local Community Health Need Assessment, 2023 Kids Count data, and US Census information, which highlight critical community issues such as youth mental health, food security, education, and childcare.

Pre-construction planning support is needed for facility build-out and expansion; these detailed plans will provide accurate cost estimates, timeline projections, and serve as the blueprint for construction.

The YMCA has already secured \$1.85 million in matching funds for the Phase I build out, demonstrating strong community support and financial viability while simultaneously positioning it as a catalyst for future community development and investment in Shiawassee County. By addressing immediate needs while laying the groundwork for sustainable, long-term growth, this project



represents a significant investment in the county's youth, preparing the community for future growth and prosperity.

### PROJECT INFORMATION/IMPACT

A. How will this project address critical needs in your community/rural communities?

Phase I of this project will address critical needs in the rural community of Shiawassee County by significantly expanding childcare services, a crucial factor identified as stunting business and population growth in the region. The addition of 100 new childcare openings will alleviate the severe shortage, particularly benefiting low- and middle-income families struggling to access quality, licensed care. Furthermore, the project will create at least 12 full-time staff positions, contributing to local workforce development. This expansion not only addresses immediate childcare needs but also stimulates economic growth by enabling more parents to enter or remain in the workforce. The YMCA's connection to a national network of best practices will bring valuable knowledge and resources to the county, building long-term capacity for childcare and youth development services. This infusion of expertise will enhance the quality of care and support available to local families. Additionally, the project's collaborative approach, involving various community partners, ensures a comprehensive response to other critical community issues such as youth mental health, food security, and education, contributing to specific facilities to be built in Phase II.

B. How will the project be sustainable at completion and long-term?

The Shiawassee Family YMCA's expansion project is designed for long-term sustainability through several key strategies. Firstly, the YMCA's established reputation and experience as the largest provider of childcare in the U.S. ensures a solid operational foundation. The organization's national network provides access to best practices for efficient and effective management. Financial sustainability is supported by the strong community backing, evidenced by the \$1.85 million already secured in matching funds. This demonstrates local investment and commitment to the project's success. The expanded childcare services will generate ongoing revenue, contributing to the facility's operational costs. The Shiawassee Family YMCA anticipates securing MiLEAP (Lifelong Education, Advancement, and Potential) funding to support the program's growth. Additionally, project's focus on including green building initiatives and sustainable features will lead to long-term cost savings in energy and maintenance. This forward-thinking approach not only reduces operational expenses but also aligns with growing environmental consciousness, potentially attracting more community support and grants. Lastly, the comprehensive nature of the project, addressing multiple community needs beyond childcare, positions the YMCA as an essential community hub. This multifaceted role enhances its value and ensures continued community engagement and support. For construction, the YMCA has identified and pursued various funding sources (see Section E).

C. What do you anticipate will be the near-term and long-term impacts of the project?

In the near term, the Shiawassee Family YMCA expansion project will significantly alleviate the critical childcare shortage in the county. The addition of 100 new childcare spots will provide immediate relief to families struggling to find quality, licensed care. This expansion will enable more parents to enter or remain in the workforce, boosting local economic activity. The creation of at least 12 full-time staff positions will contribute to local employment opportunities, further stimulating the local economy. The project will also provide enhanced youth programs and sports



activities, improving the overall quality of life for families in the area. Long-term impacts include sustained economic growth as the improved childcare infrastructure attracts new businesses and residents to the area. The project's focus on youth development and community engagement will likely lead to improved educational outcomes and stronger social cohesion within Shiawassee County. Phase II will support a continuation of providing essential community services to county residents and will further impact education, food security, and healthy and active lifestyles. Furthermore, the YMCA's commitment to sustainable building practices will serve as a model for future developments, potentially inspiring more environmentally conscious construction in the region. The expanded facility will continue to serve as a vital community hub, fostering long-term resilience and community well-being.

D. How does this project demonstrate multi-jurisdictional collaboration and cross-sector partnerships?

The Shiawassee Family YMCA expansion project demonstrates strong multi-jurisdictional collaboration and cross-sector partnerships through its diverse network of supporters and stakeholders. The project involves cooperation between the YMCA, local government entities like the City of Owosso, educational institutions such as the Owosso Public Schools, and community organizations like the Shiawassee District Library and Shiawassee Hope.
