Proposed activities include the following:

- 1. Convene a multisector coalition comprised of stakeholders that make up Michigan's 4th trimester ecosystem, with a focus on mental health.
- 2. Catalog and map the numerous initiatives and programs that comprise the ecosystem.

- 3. Identify structural gaps in the ecosystem.
- 4. Develop a portfolio of initiatives to fill those gaps.

Expected Deliverables include the following:

- 1. Organized statewide multisector, multi-stakeholder coalition committed to improving maternal mental health in the 4th trimester.
- 2. A visual and accompanying written documentation of Michigan's current state postpartum ecosystem.
- 3. A list of the structural gaps and deficiencies in the ecosystem.
- 4. A portfolio of initiatives and programs to address those structural gaps.

Anticipated Outcomes. A documented and resourced plan for the establishment of a coordinated, cohesive, and effective postpartum ecosystem in the state of Michigan.
