Upgrading the 22-year-old Sutphen fire ladder truck in Sterling Heights is crucial to enhance public safety and reduce insurance costs. A new truck will ensure compliance with Insurance Services Office (ISO) standards, keeping insurance premiums low for residents and businesses by maintaining a high Public Protection Classification (PPC) rating.

The existing truck is reaching the end of its useful life of 20 years. While the Sterling Heights Fire Department prides itself on maintaining high standards of equipment maintenance and upkeep,tThe outdated truck struggles with operational, equipment, and reliability issues due to its age. By replacing it, the Fire Department can provide more efficient and reliable emergency services. The National Fire Protection Association (NFPA) recommends replacing a fire apparatus every 20 years to meet current performance and safety requirements, ensuring firefighter and community safety.

Sutphen's proven Aerial Ladder Truck mid-mount design provides superior weight distribution on chassis, extraordinary maneuverability, and easy access to the pumper-like hose bed, as there are no hose chutes or turntable in the way. The extruded-aluminum ladder is highly resistant to corrosion and has extraordinary strength and torsional rigidity, resulting in a 3:1 safety factor.

A recent Community Risk Assessment (CRA) highlights the need for a modern ladder truck to cater to Sterling Heights' growing population and evolving infrastructure. With enhanced capabilities for high-rise rescues and firefighting operations, a newer truck offers better maneuverability and storage, ultimately improving service delivery for the entire community—visitors, businesses, and residents alike.
