Red Run Bridge

Funding Request

\$1,500,000

A component of the City of Sterling
Heights Pathway to Play and Preservation
initiative (PPP), the development of Red
Run Park seeks to add new recreation
amenities in the southeast portion of the City. To enhance
regional connectivity, the City intends to connect the park with
a new trail section of the Iron Belle Trail that will be constructed
on the other side of Red Run Drain. The bridge crossing is a key
component to making this vision reality.



Currently a vacant, city-owned 14.9-acre parcel, development is critical as the southeast quadrant of Sterling Heights lacks open park space. The park will intersect with the proposed Iron Belle Trail and connect to L.W. Baumgartner Park via a pedestrian bridge. This will create a full-service recreational outdoor space for area residents. Planned improvements and amenities include:

- · Dog park
- Outdoor pickleball courts
- An internal asphalt path for hikers and bikers
- Restroom facility
- · Two picnic shelters
- A nature observation deck over the Red Run Drain

Iron Belle Trail Connector

The City wishes to connect a current gap along the Iron Belle Trail (IBT) that travels through Sterling Heights along an ITC easement in the southern part of the City. This trail alignment is being evaluated as an alternative to the proposed IBT route along Schoenherr Road, a five-lane principal arterial road.

The proposed greenway would be more consistent with the remainder of the IBT trails in the City, which run primarily along the Clinton River greenway, as well as complete the IBT through the City of Sterling Heights. The City has previously worked with ITC to plan and construct trails along ITC easements in the northern part of the City.
