ACC's current structure for its Youth Center program is no longer suitable to meet the needs of its programming. A new structure on the site is being engineered to provide the space and equipment to successfully continue the ACC's Youth Programs.

The rough estimate for the new facility is 30,000 square feet. We are seeking \$10 Million toward construction costs.

ACC's Youth Programs provide a safe haven for hundreds of youths. Services include educational activities tailored to develop and enhance academic and social skills while promoting leadership skills to gear youth in making healthy and productive decisions to improve their quality of life.

The ACC After-School Program provides at-risk youth ages 9 -17 with the support and essential life skills needed to improve academic status, reduce risk-taking behaviors, increase accessibility to health services, and improve youth sense of self-image.

Services include academic assistance, tutoring, computer skills training, STEM activities, servicelearning projects, physical education and recreation, mentoring, substance abuse prevention, violence prevention and conflict resolution.

Recreational activities for youth are provided year-round at ACC's Youth Recreation and Leadership Center in Detroit to assist in guiding youth through everyday challenges and promote healthy life choices.

Recreational services attract and engage at-risk youth while providing a safe place to be when not in school.

Activities are age appropriate and tailored to all skill levels.

Those with advanced skills and who are performing well in school, are invited to be a part of ACC's Traveling Basketball Team. ACC's travel basketball team participates in state wide competitions. These competitions provide youth with the opportunity to travel and gain exposure to new experiences. As a result of ACC's youth after school programs and recreational activities, many of ACC's students continue their education and athletic careers in college.

As part of its youth services, ACC's Mentoring Program provides at-risk youth an opportunity to develop strong and trusting relationships with their fathers and other adult mentors. The mentoring program brings together youth, fathers, and other caring adults interested in keeping families and neighborhoods together. The program works to teach youth to value respect and inspires them to stay in school and achieve. Activities include one-on-one mentoring, social enrichment workshops, motivational presentations featuring guest speakers, tutoring, field trips, and community service. As a result of individual achievement, program staff reward youth with trophies to promote successful behavior and encourage goal setting. The mentoring program's ultimate goal is to provide youth with a sense of security and establish trusting relationships to improve their future's prospects.

#### THE ACC YOUTH PROGRAM

We've designed our youth program to nurture and empower several hundred young people in the Seven Mile Area. Our facility is a safe haven for educational activities, enrichment, and recreation. The ACC youth mission is to promote responsible behavior to gear young people to make better choices, thrive, and improve their overall quality of life.

The ACC After School Program offers at-risk youth ages 9-17 with support and essential life skills to improve academic status, reduce risk taking behaviors and improve confidence and self-image. Our services include academic assistance, tutoring, computer skills training, service-learning projects, physical education and recreation, mentoring, substance abuse prevention, and conflict resolution. We're attentive to academic progress and areas of struggle in order to design the proper path forward for each young person within our program. These measuring tools are the ACC difference.
