The Merit Cybersecurity Operations Center (SOC) provides 24x7x365 active threat hunting and real-time response by dedicated cybersecurity analysts, ensuring constant vigilance across campus networks. By leveraging a shared-service model, institutions can

maximize the value of existing investments and realize up to 4x cost savings on monitoring and alerting—compared to the expense of maintaining independent campusbased SOCs.

One-time appropriations sought to get the cybersecurity center operational, then it becomes self-sufficient and will be able to eventually expand to community colleges and other community anchor institutions.
