The impact of this funding

will be felt in communities throughout Michigan, including Adrian, Alpena, Bay City, Benton Harbor, Bridgman, Brimley, Detroit, Douglas, Eastpointe, Essexville, Flint, Grand Rapids, Highland Park, Holland, Hudson, Kalamazoo, Lansing, Menominee, Muskegon, Pinconning, Saginaw. This funding will support youth in our rural communities, suburban communities, and our cities. Importantly, this funding will also provide crucial support to potentially 40,000 youth across our state. This funding will ensure that a significant number of youths have access to these vital programs.

These programs will provide a significant public benefit and be an appropriate use of taxpayer funding for a number of key reasons. A study by the University of Michigan Ann Arbor found that every dollar invested in Boys & Girls Clubs returns \$6.79 in economic benefits to a Boys & Girls Clubs' community. Boys & Girls Clubs' workforce development programs equip young people with valuable skills, training, and certifications relevant to current and future job markets. This investment will create a more skilled workforce across the state of Michigan.

Boys & Girls Clubs' programs will provide the next generation of workforce with the skills that they need to be successful and ready to be employed. This will contribute to lower unemployment rates, thus reducing the amount of people needing public assistance programs and strengthening our tax base.

Boys & Girls Clubs often have strong community support and partnerships, which can only ensure programs are tailored to respond to local needs.

Boys & Girls Clubs will provide comprehensive programming-- job exploration, skill-building, and transition acumen-- that promotes a source of reliable workers, strengthens readiness for the workforce, and creates a talent pipeline in our state.
