#### **Navigator Program**

#### **Background Information and Key Issue**

The Autism Alliance of Michigan's Navigator program was created in 2014 to help families living with autism across Michigan struggling to secure services, supports and professional guidance when faced with an autism diagnosis. It is a statewide, central resource offered at no cost to any Michigan family. Our professionals are skilled in multiple areas of autism/disability related fields in order to adequately and comprehensively address the multiple, varied needs our families experience across the lifespan. Since inception, we have served almost 20,000 families directly and thousands more through our community education and training initiatives.

#### Current (2025) Funding and Capacity

- In the FY2025 budget the navigator program is currently funded by a \$2.025M DHHS grant, within the Autism Services budget line, matched at 25% by AAoM's private fundraising, creating a successful public-private partnership
- The program is currently staffed by 8 navigators, 5 specialists, and 3 outreach professionals to serve the entire state
- This funding level has allowed AAoM to serve 3,500-4,000 individuals and their families in every region, addressing a multitude of varied, complex cases

#### **2026 Executive Budget**

- The 2026 Executive budget includes navigator funding again, at the \$2.025M level
- We are asking the Michigan legislature to continue the \$2.025M level to support this critical program for our state
