Dear Governor Whitmer:

As the State of Michigan funding decisions are coming hastily to the wire, we feel compelled to present you with our current dire circumstances, in the hope that you will work diligently to carve out a funding source for us in the state budget for FY 2024-25.

Crime Stoppers of Michigan is on the precipice of making drastic changes to our existing program, due to reduced contributions in recent years. Despite these reduced contributions from both corporate and private donors in a post-COVID environment, and a minimal staff of one full-time employee, six part-time employees, and volunteers from southeast Michigan communities and universities, Crime Stoppers of Michigan has maintained our extensive roster of services to all seven counties of SE Michigan. However, should we not receive assistance from the State of Michigan in FY 2024-25, we anticipate being forced to make radical reductions in the services we provide going forward.

These services expand beyond the anonymous tip line and rewards all Crime Stoppers programs specialize in, to include our public awareness communications, unique law enforcement partnerships, crime communications for victims, victim and family support, community partnerships (Humane Society, Open Arms, Communities United for Progress, Mothers of Murdered Children, etc.), Project Safe Campus (K-12 school program), and Project Good Samaritan (faith-based program). *No other organization in Michigan offers this myriad of services*.

Crime Stoppers of Michigan serves a population of 4,820,684, which, as you know, is half of Michigan's population of 9.974 million people. We cover seven of the most populated counties in the state. Other counties have requested our services, but without additional funding, we are not equipped to spread our limited resources any further.

Along with providing services for this number of residents, we support over 200 Federal, state, county, and local law enforcement agencies who seek assistance with cold and/or difficult cases.

Recently, we have understood the need to expand our mission to include helping prevent criminal activity. To that end, we have launched our **Center for Crime Prevention**. The Center offers crime prevention videos and resources, resources for parents, resources for students, crime prevention research, and our Crime Prevention Speakers Series. Our most recent effort coming from our Center for Crime Prevention is our fledgling conflict resolution program, *Pathways to Resiliency and Peace*, which partners with the faith based community to bring conflict resolution training to local communities.

What is the value of the work we do? In the last six years, Crime Stoppers of Michigan has received more than 43,000 anonymous tips and awarded more than \$600,000 in cash rewards. According to P3 Software, the tip acquisition and tip management solution that is the industry standard for Crime Stoppers programs, law enforcement agencies, and federal agency initiatives, recoveries (weapons, property, cash recovery, seizures) resulting from the Crime Stoppers of Michigan program have equaled more than \$3 million in the past five years. While this is a large amount by itself, it is difficult to monetize the value of the lives that have been saved or those positively impacted through removing weapons and drugs off our streets.

In addition, the value of our work to the victims and families we serve is not a statistic easily measured. Families come to us broken, disheartened, and feeling *the system* is not working for them. Once here, they receive compassion, care, and competency. They leave strengthened, encouraged and hopeful. That is a value to Michigan residents victimized





by crime that cannot be quantified.

The following law enforcement officials strongly feel that Crime Stoppers of Michigan is an asset to the State of Michigan, worthy of funding. We sincerely hope that you and your colleagues will adjudicate favorably on our behalf.

Crime Stoppers of Michigan provides citizens in the seven counties of SE Michigan an anonymous and safe method for reporting information on a host of crimes through the 1-800 SpeakUp Program as well as delivering personal safety information through The Center for Crime Prevention.

### Crime Stoppers of Michigan is the only community based non-profit advocating for crime victims and their families

#### **Goals and Objectives**

- \*Increase citizen involvement and cooperation which results in reducing the opportunity for crime to occur
- \*To furnish law enforcement with information on crimes and other criminal activity that they otherwise would not be able to obtain
- \*To prevent crime through public education
- \*Reduce and deter crime in the seven counties of Southeast Michigan
- \*To provide after-care for victims and their families

#### **Service Operations**

Either a Federal, State, County or local law enforcement agency and/ or a victim's family requests that Crime Stoppers of Michigan use their tools to get specific crime information to the general public with the objective of soliciting anonymous tips that may re-start a stalled investigation and/or provide enough details regarding a current case to facilitate an arrest.

In a number of cases information has been received regarding a criminal activity being planned.

All services provided by Crime Stoppers of Michigan are free of charge

#### Service Delivery/Public Awareness

Citizens are made aware of the services provided through nine community outreach programs provided to SE Michigan:

<u>Crime Communication</u> – Publicizing crime information to the public

<u>Project: Safe Campus</u> - K-12 program specific to schoolchildren

Faith Based Outreach - Over 300 churches involved

Prison Outreach - 32 Michigan State Prisons / 6 County Jails

<u>Law Enforcement Partnerships</u> - Working with over 200 Federal, State, County and City agencies

<u>Crime Prevention Presentations</u> – Providing safety information to Neighborhoods; Social Groups; Other Organizations

<u>Public Speakers Bureau</u>- Introducing the 1-800 program of our citizens

<u>Crime Victim and Family Support</u>- Bi-monthly support group meetings

<u>Community Groups Partnerships</u> – With programs including Cease Fire, National Night Out, Thou Shall Not Kill, Open Arms, Detroit 300, Communities United for Progress, suburban Neighborhood Watch Groups, and social/community organizations throughout SE Michigan.

#### **Competing Organizations**

There is not another nonprofit in SE Michigan that supports crime prevention initiatives in the manner in which Crime Stoppers does.

#### **Assets**

Assets of Crime Stoppers of Michigan are derived from contributions from civic, corporate and law enforcement relationships, as well as yearly fund raising events.

#### **Program Outcomes**

Crime Stoppers of Michigan works to impact crime reduction throughout SE Michigan by directly supporting crime prevention initiatives.

Provides a safe vehicle for citizens to report crime/Alternative to silence

Provides crime prevention information for citizens to remain safe

Citizen's awareness reduces the opportunity for crime to occur

Provides a vehicle for victims/families to seek help from the public

Helps victims/families navigate the aftermath of crime and the criminal justice process with dignity and resilience.

Creates stronger community support of Law Enforcement

Expedites Law Enforcement investigations by providing critical information

Increases the possibility of arrest/capture

#### **Program Results:**

Over the last six years, Crime Stoppers of Michigan has received over 40,000 anonymous tips through our 1800 SpeakUp Program, resulting in awarding approximately \$600,000. 55% of these tips involved information on crimes committed in the suburbs.

Tips and information received include crimes of stabbings, sexual assault, counterfeiting, drugs, armed robbery, missing persons, auto theft, wanted fugitives, animal cruelty, human trafficking and homicides.

Citizens have a safe and secure method to help law enforcement solve crime in their communities.

Because of the investigations and arrests resulting from these tips, in 2024, \$424,756 of recoveries were reported by law enforcement. This total includes guns taken off the street, stolen vehicles recovered, cash, stolen property and street value of drugs seized.

Over the last Eleven years, the recovery total is \$3,398,305

#### <u>Tips/Rewards for the Seven Counties of Southeast Michigan:</u>

Year 2021	4,800	Cash Rewards Approved- \$54,200
Year 2022	4,690	Cash Rewards Approved- \$49,000
Year 2023	4,876	Cash Rewards Approved- \$49,250
Year 2024	4,001	Cash Rewards Approved-\$44,400

40% of information submitted through 1-800speakup are regarding crimes in the City of Detroit

60% of information submitted through 1800speakup are regarding crimes in the suburbs

In 2023, less than 30% of those awarded rewards choose to accept them

#### **Other Information**

Crime Stoppers of Michigan has a part-time representative working in the homicide unit of the Detroit Police Department to ensure the continual flow of tip information

Service to other squads within the department are also provided

Between 2019 and 2024 Crime Stopper representatives and their volunteers have participated in over 1,200 community events and/or crime prevention presentations throughout SE Michigan.

Crime Stoppers of Michigan continues to work in cooperation with the Detroit Police Department on the Detroit Rewards TV program.

Over this same period, victims/ their families and the law enforcement community were directly supported with the following:

100 victim/family support meetings / Referred to other supporting agencies

500 press conferences

750 news releases

215,200 printed posters

84,700 printed door hangers

2,500 news pieces covered by the media
