The public purpose of this project is to support the establishment and sustainable growth of social enterprises to provide marginalized Michigan residents employment opportunities, with an emphasis on people with disabilities. This will be done by creating innovative pathways to entrepreneurship and workforce integration.

The current labor force participation rate among those with disabilities is 23.9%, compared to 68.1% for the general population. People with disabilities are ready, willing,

and able to seek independence, jobs, and careers. Current employment practices and publicly funded employment services have not substantively changed outcomes and employment prospects for our most disenfranchised (potential) workers on any significant scale.

Social enterprises serve as pivotal agents of change, adeptly addressing pressing societal challenges while simultaneously fostering job creation, spurring economic advancement, and fortifying community resilience.

Though they take many forms across many industries, they ultimately exist to serve the common good.

- Social enterprises focus on generating revenue from goods and services not just grants, donations, or exclusive reliance on publicly funded services.
- They incorporate nonprofit and for-profit business structures.
- Employment related models offer jobs and job training for individuals who might otherwise have limited opportunities and support.

The advancement of the Center for Social Enterprise Development, convened collaboratively between the Small Business Association of Michigan (SBAM) and Incompass Michigan, through the SBAM Foundation, focuses on employment-related social enterprises as a means to drive sustainable change in the employment landscape for people underrepresented in the workforce.

#### **EXECUTIVE SUMMARY**

At a time of consistently low unemployment and high worker shortages, the labor force participation rate among those with disabilities is unacceptably low at 24.5%, compared to 67.6% for the general population. People with disabilities are ready, willing, and able to seek independence, jobs, and careers. Current employment practices and publicly funded employment services have not substantively changed outcomes and employment prospects for our most disenfranchised (potential) workers on any significant scale.

We seek to develop and activate new, sustainable business models, leveraging the creativity of entrepreneurs and the private sector, together with a statewide network of human service providers, to create opportunities for more people. Both non-profit and for-profit organizations have a role to play as we seek to catalyze job creation, promote economic development, and reduce reliance on philanthropy or fee-for-service reimbursements in favor of more sustainable, self-reliant employment models. This will require significant retooling of hiring practices, training, workplace supports, transportation services and more. To be successful, new practices must be developed, tested, and scaled – which is unlikely to spontaneously occur without an intentional, focused, and well-funded effort.

Incompass Michigan, in collaboration with the Small Business Association of Michigan (SBAM), propose a state investment to foster the development of employment-related social enterprises across Michigan.\* Our initiative aims to empower previously disenfranchised residents, including people with disabilities, returning citizens, and individuals facing other significant barriers to employment, by creating innovative pathways to workforce integration.

#### THE GOAL AND THE TEAM

Incompass Michigan is a statewide network of mission driven organizations promoting community access and inclusion for people with disabilities and other barriers.

The Small Business Association of Michigan is a statewide and state-based association of more than 32,000 members that serves the needs of Michigan's small business community. Established in 1969, it serves entrepreneurs in all 83 counties of Michigan.

Our first-of-its-kind proposal leverages the extensive experience and capabilities of both organizations to meet a pressing need. The Center for Social Enterprise Development will research and disseminate best-practices for social enterprise establishment and growth, creating a community of social enterprise businesses and support employment-related social enterprises as a means to drive sustainable change in the employment landscape for people underrepresented in the workforce.

#### **PROBLEM STATEMENT**

In Michigan, the landscape of workforce integration presents a formidable challenge, particularly for marginalized populations such as individuals with disabilities and returning citizens. The conventional channels of employment often prove inadequate in meeting their unique needs, leading to the perpetuation of economic disparities and impeding their full inclusion in society.

The COVID-19 pandemic exasperated the status quo, inflicting unprecedented strain on this population and negatively impacted many organizations focused on inclusive employment. This compounding effect underscores the urgent imperative for strategic interventions aimed at not only sustaining but also expanding sustainable social enterprises. By addressing these multifaceted obstacles head-on, we not only aim to uplift and empower these underserved communities but also foster a more equitable and resilient economic landscape for all Michiganders.

## SOLUTION

The goal of a more inclusive employment landscape is ambitious and requires intentional, focused effort. Our dynamic proposal requests the allocation of \$2,000,000 by the State of Michigan to establish the Center for Social Enterprise Development with a focus on expansion of employment-centric social enterprises. Social enterprises serve as pivotal agents of change, adeptly addressing pressing societal challenges while simultaneously fostering job creation, spurring economic advancement, and fortifying community resilience. The Center would serve at least 50 employment-centric social enterprises with direct grants, technical assistance, and programming.

The Center will establish an advisory board of experienced social enterprises who will oversee the development of best practices in sustainable business models. It will also assist entrepreneurs, for-profits, and non-profits in business modeling, strategic formulation, market analysis, and implementation, in the social enterprise space. Our initiative is poised to arm these organizations with the requisite tools and support systems to not only survive but also flourish, thereby amplifying their capacity to effectuate tangible and sustainable social change.

Our vision is for the Center for Social Enterprise Development to stand as a beacon of innovation and empowerment, leveraging the private sector (both for and non-profits) to revolutionize Michigan's socio-economic landscape. By cultivating a dynamic ecosystem of collaboration, mentorship, and resource-sharing, our initiative seeks to unleash the latent potential hidden within our workforce, propelling them toward independence, growth, and impact. Through strategic partnerships with industry leaders, academic institutions, government agencies, and community stakeholders, we aspire to foster an environment conducive to experimentation, learning, and adaptation, enabling these enterprises to transcend traditional constraints and emerge as trailblazers in the pursuit of social and economic justice.

At its core, our proposal embodies a bold vision for a more equitable and inclusive future, one where the transformative power of social enterprise serves as a catalyst for meaningful societal change in employment. By harnessing the collective ingenuity, passion, and resilience of Michigan's diverse communities, we aspire to cultivate a thriving ecosystem of innovation and opportunity, where every individual, regardless of background or circumstance, can realize their full potential.

#### **DIRECT GRANTS**

To bolster implementation of social enterprise advancement, this proposal would dedicate \$1,800,000 of the funding to go toward the establishment of a competitive grant program, wherein eligible organizations will receive funding of up to \$40,000 to implement, transition, or grow their social enterprise initiatives. Emphasizing collaboration, innovation, and measurable outcomes, we will prioritize projects that demonstrate a clear commitment to workforce development, community empowerment, and sustainability.

To be eligible for these direct grants, applicants must participate in programs offered by the Center for Social Enterprise Development. Technical assistance and mentorship opportunities will enhance the capacity of grantees to achieve their objectives and navigate operational challenges. Grant proceeds would cover the cost of services such as:

- a. Business modeling for new social enterprise
- b. Strategic and business plan development for a new social enterprise or transitioning existing business into an employment related social enterprise
- c. Market research and feasibility assessment for a new social enterprise or transitioning an existing business into an employment related social enterprise
- d. Implementation, including marketing and impact evaluation for a new social enterprise or transitioning business into an employment related social enterprise

Investing in the Center for Social Enterprise Development will yield significant benefits for Michigan's economy and society. By fostering the development and scaling of employment-related social enterprises, this initiative will catalyze job creation, spur economic growth, and reduce reliance on philanthropy or publicly funded services.
