# Value of the Department of Labor and Economic Opportunity Symphony Economic Recovery Grant

Interlochen Arts Academy (IAA) and its Orchestra operate as a part of Interlochen Center for the Arts (founded in 1928). Our Music Division has been the largest part of our Academy since its inception in 1962, and the IAA Orchestra has been widely recognized as one of the finest high school orchestras in the country for decades.

The support of the LEO Symphony Grant program is especially impactful as Interlochen celebrates its centennial in 2028 as a leader in creative youth development. Over the next three years, we aspire to highlight Interlochen and our impact on the arts in our local community, across Michigan, and beyond through a series of residencies by guest artists and two major tours, including IAA young artists and alumni.

The 2025 LEO Symphony Grant is allowing us to support this programming. The grant will be used this coming year to support a major tour with performances in Interlochen, Detroit, Philadelphia, and Boston as part of the America at 250 celebrations. These performances will feature GRAMMY® Award-winning conductor Cristian Măcelaru, world-renowned cellist Yo-Yo Ma, emerging cellist and Interlochen Arts Academy alumnus Joshua McClendon, and a new work by composer Wynton Marsalis. Our Academy Orchestra will partner with the Detroit Symphony Orchestra, The Philadelphia Orchestra, and the Boston Symphony Orchestra.

The Symphony Grant has given Interlochen meaningful support for the Michigan-based performances and leveraged additional philanthropic support to pursue this larger vision. This project will bring national attention to our local community and our state, highlighting the quality of our arts and culture sector. In addition to statewide coverage, this tour has already been highlighted in the *Boston Globe*. We anticipate more positive recognition as the tour approaches in 2026. Furthermore, initiatives like this allow us to attract the finest young musicians to Interlochen, which is essential to our financial and mission health.

Recognized across the country and around the world, Interlochen is proud to be a Michigan institution. We will represent our local community and our home state with pride, and we appreciate the support of this grant program to make all of this possible.
