### **GLWA'S FY 2026 STATE APPROPRIATION REQUESTS**

#### **About GLWA**

The Great Lakes Water Authority (GLWA) is a regional water and wastewater authority, providing drinking water services to nearly 40% and wastewater services to nearly 30% of the state's population, including 115 communities in southeast Michigan. GLWA operates five water treatment facilities that draw water from Lake Huron and the Detroit River and operates 797 miles of water transmission mains to deliver that water to communities. GLWA manages wastewater collection and treatment across the region as well with the largest single-site treatment facility in North America.

#### **GLWA's \$25 Million FY 2026 State Appropriations Request**

#### Wastewater

- \$10 million to be used for wastewater system resiliency and flood mitigation projects. The projects:
  - o Improve resiliency by maximizing capacity to receive wastewater flow in significant rain events and reduces the likelihood of sewer flooding events.
  - o Improves water quality by providing additional wastewater retention and treatment capabilities and reducing the potential for Sanitary Sewer Overflow (SSO).

#### Drinking Water

- \$15 million to be used for water quality, system resiliency, and flood mitigation projects. The projects:
  - o Reduce the overall risk of pipeline failure and improves levels of service for communities.
  - Help prevent failures, reduce impacts on water quality and avoid widespread precautionary boil water advisories that often cause significant public disruption and expenses.
  - o Support long-term affordability by identifying and replacing specific at-risk asset sections within a main, and renewing those assets rather than replacing the entire main. This reduces total cost and extends useful asset life by as much as 50 years.
