**Project Location:** Atwood Park

### **Project Description:**

On behalf of the City of Wayne, we are requesting grant funding to support the replacement of the walking path in Atwood Park. Atwood Park is the city's largest park (27 acres) and is one of the most utilized; serving as a vital hub for recreation, exercise, and social engagement.

The current walking path, originally installed over 30 years ago, has reached the end of its lifecycle. Years of wear, weathering, and heavy usage have left the surface cracked, uneven, and unsafe, creating hazards for walkers, runners, and individuals with mobility challenges. We recently partnered with Wayne RESA and the Wayne Public library to place a Story Book Walk along the path. The deterioration not only diminishes the overall park experience but also discourages community members from engaging in healthy activities.

In 2021, with the help of Community Development Block Grant funding, we were able to replace a decades old wooden play structure. The new structure has been attracting hundreds of children daily and has increased traffic exponentially. In 2021 we also replaced the deteriorating split rail fence that surrounds most of the park.

First and foremost, the safety of park goers is a top priority. The one-mile-long walk path is in disrepair and has become a potential liability. Unfortunately, due to financial constraints the City is unable to fund the replacement of the path.

## The key components of the project include:

- Removal of existing walk path
- Grade and shaping of gravel base
- Install 52,900 sq ft. (8ft. wide path) of 3" of MDOT #5E1 asphalt
- Restoration of areas adjacent to path]
- Placement of concrete bollard posts (4) @ \$9,000.00/ea.

## Funding Request: \$212.000.00

### **Project Impact:**

Removing and replacing this mile long path will not only mitigate risk but draw more walkers to the park. We are proud to partner with different organizations to create opportunities for families to visit the park. Having the path repaired will give us the ability to attract more projects.
