KEY ACHIEVEMENTS

Land Acquisition and Site Approval

A major milestone was achieved with the successful purchase of 4.6 acres of land at 51333 Cherry Hill in Canton, MI.

This site has received site approval from Canton Township, including a necessary zoning change, and will be the future home of ILA's residential complex.

Strategic Partnerships

ILA established incredibly valuable partnerships with key organizations, including fully executed agreements with Special Olympics of Michigan and Canton Township's Therapeutic Recreation Division.

These partnerships will provide invaluable resources, programming, and support for our future residents, contributing to healthy and active lifestyles and lifelong learning opportunities.

Fundraising Success

In 2024, ILA raised over \$250,000 towards the purchase of the property, demonstrating strong community support for our vision. This included a particularly successful year-end fundraising campaign, the "60/60 Initiative." This effort secured a matching donation program, enabling us to double our fundraising over 60 days in November and December. Through the dedicated efforts of our volunteer committee and board members, we successfully raised more than the target which was matched by a private donation, effectively totaling \$205,000.



ORGANIZATIONAL DEVELOPMENT

ILA has focused on strengthening its organizational infrastructure through several key initiatives:

Michigan Nonprofit Association (MNA) Membership: We became a member of MNA, gaining access to grant opportunities, discounted services (including retirement plans, group benefits, job postings, HR services, and more), networking and educational opportunities, and public policy advocacy.

Sub-Committee Formation: We successfully formed volunteer sub-committees focused on fundraising, local community outreach, public relations, and corporate outreach, enhancing our capacity in these critical areas.

Professional Grant Writing: ILA secured a contract with a professional grant writer, resulting in the development of essential organizational documents that will support our long-term fundraising efforts.


Enhanced Online Presence: We have continued to develop our website and expand our social media presence, increasing our reach and impact within the community.
