

Description & Site Features

- Creating a loop path that connects the neighborhood from the north, east and south
- Installing a multi-age play area at the north end of the park, integrated into the expanded sledding hill
- Placing a social space adjacent to the play area
- Reconstructing two softball/baseball fields for middle school age groups, using synthetic or natural turf
- Restoring an open field at the north end to allow for open play or small soccer games

SUPPORT FOR THE CITY OF OAK PARK TO NEGOTIATE AN AGREEMENT WITH THE BERKLEY SCHOOL DISTRICT FOR IMPROVEMENTS TO TYLER PARK

WHEREAS, the Berkley School District is the owner of a parcel of land adjacent to its Tyndall Center located in the City of Oak Park, Oakland County, Michigan, and commonly known as 14501 Talbot, Oak Park Michigan 48237 (the "School Property"); and

WHEREAS, the City also is the owner of a parcel of land adjacent to the School Property located in the City of Oak Park, Oakland County, Michigan, and commonly known as Tyler Park, 14700 Lincoln Street, Oak Park, Michigan 48237 (the "City Property"); and

WHEREAS, the Berkley School District is planning a large investment in Tyndall and Tyler Park; and

WHEREAS, the City of Oak Park identified Tyler Park as a priority park in the Parks and Recreation Master Plan, and listed investments to Tyler Park in our Capital Improvement Plan in Fiscal Years 2027 and 2028; and

WHEREAS, the City of Oak Park's Recreation Master Plan lists "Improve equitable access to parks and amenities to encourage participation and active lifestyles for all age groups and abilities;" and

WHEREAS, the City of Oak Park's Strategic Plan lists "identify the best uses for City property to ensure equitable access to quality public spaces" and "Partner with neighboring jurisdictions, as appropriate, to accomplish common goals and maximize efficiencies;" as objectives and

WHEREAS, the City of Oak Park and the Berkley School District each realize the benefit in completing improvements to Tyndall and Tyler Park as a combined project;

BE IT HEREBY RESOLVED, that the Oak Park City Council support the negotiation of an intergovernmental agreement to carry out improvements to the Tyndall and Tyler Park in partnership.
