The city of Warren is seeking a \$1 million funding allocation to repair and restore the Red Run Drain in Warren, Michigan, a crucial infrastructure project that directly impacts the efforts to prevent basement flooding. The Red Run Drain, an essential component of the region's stormwater management system, has had frequent flooding events that affect homes, businesses, and public safety. These recurring floods not only cause extensive

property damage but also pose health risks to residents due to stagnant water and the potential spread of contaminants

Last year, the city opened a new detention basin that can hold up to 22 million gallons of water; however, more work needs to be done to reduce basement flooding and enhance the overall quality of life for residents in Warren.
