Standard operating procedure for 911 calls is dispatch of law enforcement or emergency medical services(EMS). However, when there is a mental health crisis other response options are optimal and can save law enforcement time for more urgent public safety issues. Behavioral Health Emergency Response(BHER) is being fortified through the 988 crisis line, county level mobile crisis units, crisis stabilization units and behavioral health urgent care-however, collaboration and coordination with 911 requires enhancement to

ensure that the event acuity and public safety risk are matched to an appropriate response type. CBHJ will work with county level administrators, PSAPs, and CMH to ensure such coordination, however, this coordination will require training on identification, coding and triaging of the behavioral health issue. as well as upgrades in technology to enhance communication between systems.
