### **Brief Description of the Project:**

The City of Albion's Public Safety Initiative encompasses a range of essential items vital for ensuring the operational readiness of our public safety personnel. This comprehensive breakdown prioritizes accountability and transparency in operations through the acquisition of essential equipment. This includes \$10,000 for 20 additional body cameras, \$3,000 for Redaction Software, and \$18,700 for Cloud Storage System. These investments not only update our current equipment but also ensure optimal functionality and compliance with modern standards, thereby enhancing the safety and effectiveness of our public safety personnel. The total funding request for this comprehensive initiative amounts to \$31,700.00.

## Albion, Michigan Region:

Albion, located in Calhoun County, Michigan, lies in the south-central region of the Lower Peninsula. As of the 2010 census, its population stood at 8,616, making it a part of the Battle Creek Metropolitan Statistical Area. The demographic breakdown reflects a diverse community, with 62.4% identifying as White, 32.1% as Black or African American, 0.2% as American Indian and Alaska Native, and 0.5% as Asian.

Historically known as a factory town due to the presence of major manufacturers since the 19th century, Albion's landscape has evolved with the closure of several industrial facilities. Transitioning towards a college town model, spurred by Albion College's investments in the area, the city now embraces technology and sustainability initiatives. Its post-industrial identity is marked by ongoing infrastructure improvements and a burgeoning interest in innovation and entrepreneurship. This shift underscores Albion's commitment to diversity, economic growth, and community development.

#### Albion, MI Department of Public Safety:

The Albion Department of Public Safety (ADPS) is dedicated to enhancing community safety and quality of life through a comprehensive approach that integrates both traditional and innovative police and fire services while upholding constitutional and fundamental human rights. Our commitment to professionalism, quality, and effectiveness ensures that all members of our department always remain accountable for their actions.

Annually, ADPS compiles crime statistics for the City of Albion, utilizing data from the Michigan Incident Crime Reporting (MICR) and the Federal Bureau of Investigation Uniform Crime Report (UCR), alongside internal reports. This report serves as a crucial tool for police administration, operations, and management, enabling us to assess crime patterns in various areas and demographics. Additionally, it facilitates comparative analysis with neighboring jurisdictions to identify trends and inform strategic decisions.

Our primary objective is to provide accurate, reliable, and comprehensive crime data that reflects the nature and movement of crime within Albion, Michigan, and the United States. We are committed to enhancing the reliability and validity of our reporting system by analyzing major crime indexes and adapting to classification revisions mandated by the State.

Despite facing challenges such as staffing shortages and recruitment difficulties in 2022, ADPS remains dedicated to providing quality training to its officers. We prioritize training in various areas, including vehicle operations, firearms, defensive tactics, crisis intervention, de-escalation, cultural diversity, and supervision.

In 2022, ADPS observed a slight decrease in overall crime in Albion, with specific increases noted in Larcenies, Stalking, and Aggravated Assaults. Additionally, there was a reduction in overall calls, particularly service-type calls, and fewer criminal complaints were recorded compared to the previous year.

On the fire side, call volumes have remained steady over the last four years, except for 2020, likely influenced by changes in activity due to the pandemic. ADPS continues to actively participate in public events, fostering community engagement through initiatives such as the National Night Out celebration and the Shop with a Cop event.

Overall, ADPS remains steadfast in its commitment to enhancing public safety and serving the community with professionalism and integrity, despite the challenges faced.
