The Fred Meijer White Pine Trail State Park currently crossed Buckhorn Creek on a century-old impoundment dam that is beginning to fail. Removal of this impoundment dam and replacement with a modern bridge of adequate specifications will accomplish the following:
 - Provide emergency access to maintain and improve safety for the White Pine Trail and nearby Paris Park campground

- Infrastructure maintenance (100+ year-old dam)
- Improve year-round recreational enjoyment for pedestrians, cyclists, and snowmobilers
- Tourism and related revenue White Pine Trail and Paris Park as a destination
- Fish passage and refuge in Buckhorn Creek, a high-value, cold-water stream that supports wild trout reproduction
- Conservation and restoration of natural stream habitat

Buckhorn Creek / White Pine State Park Trail Dam Removal & Bridge Replacement

Paris, Michigan - Green Township, Mecosta County

Appropriations Request: \$250,000 towards Bridge Replacement

In 2018, the Director of the Mecosta County Parks Commission urgently contacted the Muskegon River Watershed Assembly (MRWA) when the deck on the 100-year-old, failing Buckhorn Creek Dam adjacent to the popular White Pine Trail collapsed. He was aware that MRWA and the Michigan DNR had interest in removing the dam to improve water quality and permit fish passage from the main stem of the Muskegon River into the cool refuge of Buckhorn Creek. With the safety concerns of the failure, dam removal became a priority. In addition to habitat restoration and dam safety, this project is also valuable for scenic and recreational reasons, and will maximize the State's significant investment in trout stocking at Mecosta County's adjacent Paris County Park.

Buckhorn Creek is a unique, steep gradient stream. The removal of this dam will result in a high bridge over an exceptionally scenic, pure Michigan creek. The newly installed bridge will undoubtedly be a popular stop along the White Pine Trail as visitors take in the beautiful sounds and scenery of free-flowing water.

Work to remove the Buckhorn Dam began in 2021 with \$60,000 in project design and engineering funding from the U.S. Fish and Wildlife Service. The project quickly grew in scope and cost, as there are several public utilities involved and the White Pine Trail requires significant duty-rating for bridges. The Trail is a major thoroughfare for cyclists, foot traffic, and snowmobiles at this location, providing great enjoyment and tourism-based economic activity in the area. The DNR requires a bridge that can bear the weight of a trail groomer in wintertime; and the bridge needs to be able to support emergency access vehicles to the nearby recreational areas. In addition to creating fish passage and a spectacular new view of the opened stream, the bridge has costly infrastructure requirements.

In the interest of the restoration of the natural resource found in Buckhorn Creek, MRWA is raising \$1,818,031 towards dam removal and bridge replacement. Due to changing safety and maintenance requirements, the passage of time, and inflation, the cost of this project currently exceeds available resources. To complete this important and valuable project, MRWA is seeking an appropriation of \$250,000 in State funds to ensure adequate resources for the \$1.6 million in construction costs related to dam removal and bridge reconstruction activity (15%). Should cost savings be realized, MRWA, working in conjunction with the MI-DNR and Mecosta County Parks, would seek to further enhance this historic and scenic location with additional ecological restoration, tree planting, and wayfinding / interpretive signage.
