Dear Chair Bollin:

I am writing in support of The Naomi E. James Family Center which is a newly proposed development that is to be a homeless shelter that will provide wrap around services for individuals and families that are experiencing homelessness. This facility is slated to be a transitional shelter for homeless individuals and families that will consist of 26 apartments of various sizes to accommodate those who are experiencing homelessness that seek opportunities to become stabilized. Pastor Charles O. Miles stated that their partner, Samaritas is fully engaged and is looking forward to be able to once again operate a successful, modern transitional shelter, after years of giving services and hope to homeless families in a deteriorating facility in Wayne County. Samaritas provides a range of services which include emergency shelter, transitional housing, case management, and job counseling. They also offer services to help people access resources like food stamps, Medicaid, and other benefits, as well as resources for education, employment, and childcare.

This project has been presented to the City of Ecorse by the Charles O. Miles Senior Non-Profit Housing Corporation. Pastor Miles and his team consisting of Al Bogdan, former Economic Developer Director for the State of Michigan, and Ty Hinton, the Economic and Community Development Director for both the City of Harper Woods and Highland Park, as well as serving as Executive Director of the Atlanta Housing Authority are wanting to make a positive difference within our community. Also, both Ty and Al previously served as Economic Development Directors for Wayne County.

I truly believe this project would be a vital development tool for Ecorse which will address the growing homelessness concern and the lasting impact not only the individuals themselves, who are often dealing with mental health or domestic violence issues as well as lack of living quarters, but also significantly affecting those who live in our city, conduct business in our city, our local religious organizations, infrastructure, law enforcement and social service groups.

The total development cost for this 26-unit family center will be \$16 million. Wayne County's contribution of \$5 million along with the State's contribution of \$11 million, will make this project a reality this year. Please call me if you have time, so I can help provide answers to any questions that you may have and to discuss the positive impact this development means to Wayne County and to the City of Ecorse.







# The Naomi E. James Family Center

## A Proposed New Transitional Shelter for Homeless Families in Wayne County

### **Project Summary**

We are seeking funding to build a 26-unit shelter for homeless families. The projected cost to develop and build the transitional shelter is \$15.5 million. The proposed shelter will be 31,000 square feet and will sit on a 3.52-acre site in Ecorse, Michigan. This shelter will replace the current shelter for homeless families that is located in Westland, Michigan. Wayne County has already committed \$5 million toward building the new shelter. We are requesting \$10.5 million from the State of Michigan to complete the financing for the new shelter. Attached is a "development and operating proforma" for the project. Samaritas is operating the current shelter and will also operate the replacement shelter with an annual contribution of \$400,000 plus from Wayne County. The current shelter is located on Michigan Avenue in Westland, Michigan. Attached also are (1) an aerial showing the proposed site for the shelter; (2) a rendering showing the front elevation for the shelter; (3) a preliminary Site Plan; (4) the space requirements for the shelter's operations, which will be converted to floor plans once we receive funding; (5) the IRS tax exempt letter; and (6) brief highlights and mission statement for the sponsoring Nonprofit, Charles O. Miles Senior Nonprofit Housing Corporation.

### **The Case for More Transitional Shelters for Families**

Current local statistics show that in spite of the pre-COVID economic prosperity, there is still a shortage of beds and shelters to accommodate a growing homeless population in southeast Michigan. Particularly in Wayne County, there has been a steady increase in our inability to accommodate this growing population, which includes veterans, homeless individuals, and homeless families. The proposed Family Center/transitional shelter will service the Down River, Western Wayne County area.

Funding is necessary to combat local homelessness, because there is a growing homeless population and a shortage of beds and shelters to accommodate them in southeast Michigan, particularly in Wayne County. Emergency and Transitional Housing is critical within the Down River and Western Wayne County area because it provides temporary living for a longer period of time for families and individuals, giving them an opportunity to get on their feet and try to break the homelessness cycle. The medium income is under \$40k in Ecorse, Michigan. Too many families are living from paycheck to paycheck.

There are five types of shelter services to accommodate the homeless population from state to state:

- Emergency Shelters
- Permanent Supportive Housing
- Rapid Rehousing
- Safe Havens
- Transitional Shelters

The recent trends have favored private and federal funding for Permanent Supportive Housing projects and most recently Rapid Rehousing programs. Rapid Rehousing programs are for families and individuals who

suddenly find themselves without housing due to evictions, disputes, fires, etc. Permanent Supportive Housing is the best means to provide stability for families and individuals who have been in and out of emergency and transitional shelters. Due to the demand, there is a limited period emergency, and transitional shelters have to shelter home. We will also consider accommodating a growing population of African legal refugees, who are seeking a better life in the U.S.

A most notable recent example of a Permanent Supportive Housing Development is the adaptive reuse of the old Bell Telephone Yellow Pages Building in Detroit. That project produced 155 apartments for homeless individuals. This project was sponsored by the local Neighborhood Services Organization (NSO).

The typical scenario for homeless persons or families is as follows:

- Emergency Shelters provide "overnight living" facilities to accommodate homeless individuals or families on a "first-come-first-served" basis. Individuals or families check in at night, and most are gone the following morning. If they are lucky, they can repeat the accommodation the next night.
- A Transitional Shelter provides "temporary living" for a longer period of time (90 days) for families and individuals. There are usually referrals from emergency shelter operators to a given transitional shelter, to give the homeless individuals an opportunity to get on their feet and try to break the homelessness cycle. Of course, the object is to find employment and more permanent housing accommodations.
- Permanent Supportive Housing provides families and individuals permanent shelter and "wrap-around" services. The consistent shelter and associated services give members of the chronically homeless population the best way out of their lifestyle or cycle of poverty, because of the consistent shelter and support to become self-sufficient and independent.

# The Proposed New Wayne County Family Center

We are negotiating with the Mayor and City Council to build the Naomi E. James Family Center (NEJFC) in Ecorse, Michigan. The proposed site is 401 Salliotte (Lot 280), which is located directly across the street from International Gospel Center Church. Our development team is very experienced and wants to build a 26-unit complex within a one-story building at that location. Hence, it must be well designed. We are considering a 26-unit complex that will be a mixture of apartments. The large and small units will be for families struggling to become more self-sufficient.

In addition, there will be apartments for some "rapid rehousing," because HUD insists that we be in a position to accommodate a variety of homeless persons. They will be housed for a 90-day period, while receiving supportive services to find jobs and more permanent housing. The new Family Center must also be designed for "non-congregate living." Each room/apartment must have one private space with a toilet. There will be indoor and outdoor play areas for the children, a library with computers, TV rooms, and a large community room/dining area with a commercial kitchen. There will also be storage areas for food and clothing. The Center will be a one-story building with room for families to congregate and socialize outdoors. The shelter will also be built to rigorous maintenance and energy efficiency standards.

Our current shelter on Michigan Avenue is a partnership of Samaritas and Wayne County, offering emergency shelter for homeless families. At our homeless shelter, we welcome two-parent families, single mothers or fathers with children and pregnant women.
