HOUSE STANDING COMMITTEE ON HEALTH POLICY

Tuesday, May 17th, 2016 9:00 a.m. Room 519 House Office Building

Representative Callton, Chair, called the meeting to order.

Chair Callton requested attendance be called to establish a quorum of the appointed committee members:

Representative Vaupel moved to approve the minutes from the May 10th, 2016 meeting.

There being no objection, the motion was approved by unanimous consent.

The Chair laid HB 4235 before the committee:

HB 4235 (Darany) Records; death; maternal deaths; require physicians and certain health facilities to report to department as part of health information system.

A substitute (H-2) for HB 4235 was adopted on May 10th, 2016.

The Chair laid HB 5090 and HB 5091 before the committee:

HB 5090 (Canfield) Health occupations; physicians; continuing certification requirements for physicians; prohibit as basis for license or renewal or for hospital admitting privileges.

HB 5091 (Canfield) Insurance; health benefits; insurer or health maintenance organization requiring physicians to hold certain certifications before paying or reimbursing claims; prohibit unless specifically required for licensure.

Representative Canfield introduced the bills. Questions and discussion followed.

Dr. Jayne Courts, representing the Kent County Medical Society, testified in support of the bills.
