## Support and funding for storm cleanup and replanting of red pine plantations.

- The ice storm caused catastrophic destruction of red pine plantations, a core component of Michigan's forest economy.
- Large volumes of slash (tree tops, limbs) left on the ground may significantly complicate or delay replanting efforts without coordinated cleanup and support.





# Coordination with mills to manage oversupply issues and reduce State timber sale abandonment

- Mills are nearing capacity to accept salvage timber. If mills stop accepting wood, producers may still be obligated to harvest timber sales they cannot move, putting them at financial risk.
- Timber sale extensions are necessary in other parts of the state in order to allow for greater flexibility. The DNR has pledged to work with the industry in this regard.





#### Development of long-term red pine management strategies to stabilize the market and protect jobs.

- Downed timber is deteriorating more quickly than forest producers can Without a contingency plan, producers may be forced to abandon sales, leading to contractual, environmental, and economic problems.
- The future availability of red pine sales is uncertain. A drastic reduction in red pine offered for harvest would have major impacts on mills, contractors, and forest products businesses who depend on steady supply.
- Michigan's timber industry needs to be confident that Red Pine and other commercially managed species will be available over the next 50 year in order to continue investing in Michigan.





#### **Industry Priorities – What do we Need?**

- Industry needs to be actively involved in recovery and reforestation decision-making to ensure the long-term health of Michigan's forest economy and to guide private investment decisions.
- Substantial replanting funding for the DNR, specifically focused on Red Pine across <u>both peninsulas</u>, due to the substantial ice storm losses.
- A continued effort to strengthen the woody biomass energy and residuals market, our renewable energy resource.
