JUDSON CENTER SUBSTANCE USE DISORDER PROGRAM HISTORY



- 100 Years as a non-profit provider in Southeast Michigan with offices in 6 counties (Wayne, Oakland, Macomb, Washtenaw, Genesee, Jackson counties)
 - Behavioral health
 - Foster Care
 - Autism
 - Disability Services
- Since 1996 serving Macomb County, home to our State Certified Community Behavioral Health Clinic (CCBHC)
 - Comprehensive, coordinated array of behavioral health and substance use disorder services including Medication Assisted Treatment for Opioid Use Disorder

MAT/SUD at JUDSON CENTER



Outpatient Treatment services and Medication Assisted Treatment (MAT) for Opioid Use Disorder

Multidisciplinary team to treat patients that includes a MAT medical provider, Nurse Care Manager, Community Health Worker, Recovery Coach, Psychiatric consultation

Collaborative partnerships to allow warm-handoff to services from local health care system and substance use disorder residential and detox providers treating MAT patients

On site Primary Health practice to support all health needs

Same Day/Next Day service intake



THE NUMBERS

- Macomb County has one of the highest rates of persons with Opioid Use Disorder in the State of Michigan
- Judson Center serves over 300 persons with an Opioid Use Disorder annually through outpatient treatment and MAT
- Outcome target = 50% of individuals served in MAT will achieve a reduction or cessation in opioid use
- 100% of patients are screened and receive support for primary health care and community services for Social Determinants of Health



REQUEST FOR THE APPROPRIATION of OPIOID SETTLEMENT REVENUE

- Expansion of MAT Program treatment team:
 - Nurse Care Manager (1 FTE @ \$100,000)
 - Peer Recovery Coach (1.5 FTE @ \$45,000 per FTE)
 - Community Health Worker (1 FTE @ \$55,000)
 - Medical Assistance (1 FTE @ \$68,000)
 - Staff Fringe Benefits (\$81,340)
- Expansion of MAT clinic to treat increased number of individuals through community partnership with law enforcement, diversion programs, residential substance use programs and hospital emergency departments (\$275,000 clinic expansion)

Total Funding Request: \$646,840
