## **MINUTES**

## **House Appropriations Subcommittee on Higher Education**

March 30, 2017 Room 352, Capitol Building

The subcommittee was called to order at 9:04 a.m. by Representative LaSata, Chair. All members were present.

Representative Miller moved to adopt the minutes of March 23, 2017. The minutes were approved without objection.

Representative VerHeulen moved to place the House Substitute for House Bill 4229 (H-1) Draft 2 before the subcommittee. Representative Inman seconded the motion. The motion was approved by a vote of 6-0-0.

Perry Zielak, Fiscal Analyst, House Fiscal Agency provided a brief overview of HB 4229 (H-1) Draft 2, the FY 2017-18 Higher Education budget.

Representative Hoadley moved to amend the bill as follows:
