MINUTES

House Appropriations Subcommittee on Higher Education April 12, 2018

Room 352, Capitol Building

The subcommittee was called to order at 9:01 a.m. by Representative LaSata, Chair. All members were present.

Representative Inman moved to adopt the minutes of March 15, 2018. The minutes were approved without objection.

Representative Inman moved to place the House Substitute for House Bill 5571 (H-1) Draft 2 before the subcommittee. Representative Hoadley seconded the motion. The motion was approved by a vote of 6-0-0.

Perry Zielak, Fiscal Analyst, House Fiscal Agency provided a brief overview of HB 5571 (H-1) Draft 2, the FY 2018-19 Higher Education budget.

Representative Hoadley moved to amend the bill as follows:

1. Amend page 32, line 9, by striking out all of section 274.

"(10) FOR FISCAL YEAR 2018-2019 ONLY, \$200,000.00 IS APPROPRIATED FOR THE MICHIGAN STATE UNIVERSITY EXTENSION PROGRAM, MICHIGAN NATURAL FEATURES INVENTORY, APPROPRIATED FROM GENERAL FUND/GENERAL PURPOSE MONEY.

"SEC. 274G. BEGINNING WITH THE 2018-2019 ACADEMIC YEAR, THE UNIVERSITY OF MICHIGAN ANN ARBOR SHALL RESTORE THE USE OF 'MICHIGAN TIME,' WHICH ALLOWS FOR CLASSES TO BEGIN 10 MINUTES AFTER THE LISTED START TIME.
