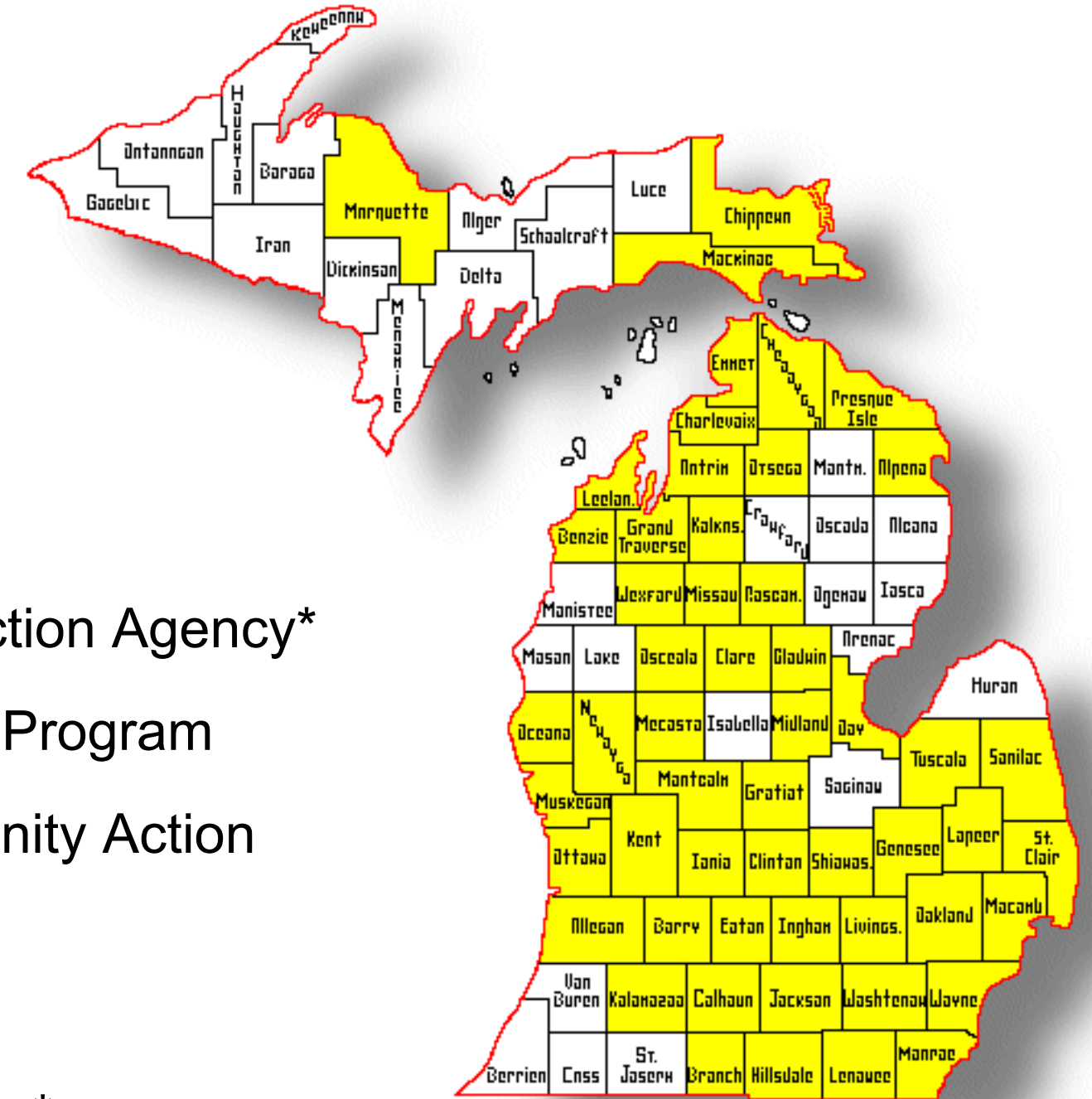




# Update

From October 1, 2024, through April 30, 2025, **our 17 grantees** have reported the following results:

- Households served: 50,986
- State returns filed: 49,260
- Total state refunds: \$32,342,662
- Federal returns filed: 49,426
- Total federal refunds: \$37,551,037

Altogether, we're approaching \$70 million in total refunds and have helped taxpayers save approximately \$15 million in filing fees.
